LIBRARY

We chose the Modesto Library today for a reason. This library has been a special part of our community for over 50 years, ever since it first opened its doors here in 1971. For generations, these walls have welcomed people from all walks of life. This is a place where anyone could come to learn, to grow, and to better themselves through books and knowledge.

This library represents what makes our community so strong - our shared values of education, understanding different views, and believing that learning can uplift all of us together.

This library has served past generations, current generations, and will serve future generations.

The past was a young boy during his summer break, he would be dropped off at the library by his single mother while she off went to work. She packed him a sack lunch and gave him a quarter to call if there was an emergency.

The present is that boy grew up to be the CEO of the County, Jody Hayes, and I am confident that this library will continue to educate the future community leaders of this area and beyond.

The past, this Library served as a study hall for a young immigrant woman who was a dental student— she utilized the books, and resources at the library to study for her exams.

Now in the present, that former student now operates dental offices throughout Stanislaus County — The future is our son, studying to be a dentist, soon will practice in this area as well.

This is great story, and the happy ending to the story for me is that I married up!

We all have stories like this, in many ways this library serves as the cornerstone of our community. So it feels right to gather here, in a place that has always brought people together. Because that's exactly what we're reaffirming today - our mission to create more opportunities for every single person in this county to achieve their full potential and move forward together.

As I look out into the crowd, I can see generations of people that have utilized the library in the past— and now in the present you take your children or grandchildren here to enrich their lives with books and learning.

But we must ensure that our library system continues to service and provide for our community for future generations to come. This is why we are investing 20 million dollars from the County general fund towards our countywide library system, and 8 million dedicated to the Modesto library, along with an additional 10 million in matching funds from the state towards this library.

But it doesn't stop here: that's when our community gets involved, and takes something that is already good and makes it better. Friends of the Modesto Library is committed to raising an additional 3 million in philanthropic dollars towards this library.

I want to thank the Committee for their handwork and dedication to upgrading this valuable resource.

This year's budget includes a \$31.8 million increase in public safety funding to further strengthen law enforcement, emergency operations, criminal justice services and provide for personnel to keep our communities safe.

The sheriff thinks that it could be higher — but on a serious note, the sheriff and the board agree that no cost is too much to protect our citizens.

District Attorney's Office; Attorney's are coming INTO the county, not leaving,
 because of the culture that our District Attorney, Jeff Laugero has created— They are
 prosecuting more cases and putting criminals behind bars.

- Public Defender's Office; 10 new positions to make sure that case loads are manageable and we can provide representation to those who need it most.
- Probation; Adding new staff and rehabilitating paroles so they can be productive members of our society.

Economic Development

\$4.6 million dollars of the \$110 million dollars we have invested in the last 2 years to create jobs, support businesses, and build out our infrastructure.

- Investments in Stanislaus 2030, paving the way for new sustainable industry
- From that we have Beam Circular that will provide the good paying jobs that are needed to live comfortably in Stanislaus
- Investment in Stanislaus Equity Partners for affordable housing and partnering with private industry to make sure we keep up with the demand in housing
- And Investments to up skill our workforce to give them the opportunity to get training or education so they are able to make better wages... a hand up, if you will

Delivering Efficient Public Services

My final priority is ensuring our county government runs efficiently and responsively for all residents. While this 1.7 billion budget includes targeted investments, we will control overall spending growth. We will strive to be good stewards of taxpayer dollars — and treat your money as we would our own personal money — prudently efficiently, and mitigating risk.

The Planning Department is rolling out new online permitting software to make building and development easier for residents and businesses.
We want people that want to invest in our county to know that we are open for business. We must be an ally, not an impediment, look for how we can make it happen not why it can't happen. To assist in helping them with projects, so they can create more jobs and economic viability for our own county.

Our aim is to position our county as a premier destination in the region with the infrastructure backbone and quality-of-life amenities to draw new businesses, investors, visitors and talent.

The State of Our County is Strong.

Our economic momentum, low unemployment, thriving businesses and powerful development are the envy of our region. Our communities are safe thanks to the

dedication of our public safety professionals. And our investments in health, education and efficient services provide every resident the opportunity to achieve their dreams.

While our county undoubtedly faces challenges, we don't shy away from them or make excuses. Instead, we tackle our biggest issues head-on, together as one community, united in this joyful purpose.

We understand that lasting progress flows not from these words or good intentions alone, but through the daily work of people rolling up their sleeves to create real, substantive change.

- We acknowledge that homelessness is an issue, and for that we are one of seven counties in the state that are implementing CARES Court to help those that need it most.
- We are expediting SB 43, so that we can help those with substance abuse issues.
 We are taking on a case that is a statewide epidemic and making sure that our actions speak louder than words.

So make no mistake. We will confront our shortcomings and missed opportunities as a community head-on, with accountability and an unwavering commitment to finally getting it right. If we do not get it right, we will be the first to tell you. If programs are not working, we will pull funding, because we are committed to not wasting your hard earned tax dollars.

As elected officials, our number one responsibility is to serve as your voice on the issues that impact your families, your neighborhoods, and our collective quality of life. We take that duty seriously, but we also recognize that effective governance is a two-way street.

So if you have a question about a local policy, a concern over an infrastructure project, or an idea to improve our community - I urge you to reach out. Call your County Supervisor, your Mayor or City Council member. Attend community meetings. Make your voice heard. Because that open line of communication is vital to ensuring we stay attuned to your priorities and can craft solutions collaboratively. We are here to listen and to respond.

At the end of the day, Stanislaus County's success does not rest on government alone, but on active, engaged citizens like yourselves. When we all stay involved and invest in

our community's future, we form an unstoppable force for positive change. Tonight, I request each of you to stay civically engaged.

Keep providing us with your feedback, ideas and motivation to drive this county forward, TOGETHER.

The County will continue to work to ensure every family can live affordably, safely, and prosperously.
