**DISCUSSION:** On December 5, 2000, the Abandoned Vehicle Abatement Program's 1994 Ford Taurus - GL 4-Door Sedan was involved in an accident and sustained major damage. The estimate received from Fleet Services to repair this vehicle is \$5,677. It has been determined that the mid-range market value of the 1994 Ford Taurus - GL 4-Door Sedan is \$4,987, which is less than the estimated cost of repairs. This leads to the conclusion that the best business decision is to replace the vehicle rather than repair the wrecked vehicle.

**ISSUE:** This action is consistent with the Board's policy of providing a safe and healthy community through aggressive removal of abandoned vehicles throughout the county.
