WHEREAS, Monday, March 12, 2001, marks the 89th anniversary of Girl Scouts of the USA, founded by Juliette Gordon Low, on March 12, 1912, in Savannah, Georgia; and,

WHEREAS, throughout its 89 year-history, Girl Scouting has inspired millions of girls and women with the highest ideals of character, conduct, and patriotism; and,

WHEREAS, Girl Scouts of the USA is the largest voluntary organization for girls in the world and recognizes that today's girls will be tomorrow's leaders; and,
