Dear Christine:

My name is Chris Ricci and my partner Greg Cunningham and his company JCD Concept 2000, Inc. and my company Chris Ricci Presents, Inc. are promoting the Xclamation Festival on Saturday, July 21, 2001 in downtown Modesto. This year, at the request of the Modesto Police Department, we are expanding the area of the festival to make it safer. The proposed area would include a portion of I Street in front of the Courthouse. After walking the site we discovered that the courthouse lawn would be an ideal place to have a bandstand. We have thought of many different kinds of music that could play on it, but we are most excited about the possibility of having the Modesto Symphony or having a Blues stage there.

After discussing our ideas with other members of local government they referred us to you as the person that I should direct this request to.

I also want to furnish you with some additional information about the Xclamation Festival. This is the downtown music and arts festival's second year. Last year's event, which took place on Saturday, July 22, 2000, took place in downtown Modesto on J Street between 10<sup>th</sup> and 13<sup>th</sup>. It included portions of 10<sup>th</sup>, 11<sup>th</sup>, and 12<sup>th</sup> streets as well between K and I streets. The event drew 12,000 people to downtown and sold out in advance. The event featured 50 bands on six stages and a Disco that took up two city blocks. The event ran from 4:00 P.M. to 12:00 A.M. The streets were open, cleared, and cleaned by 8:00 A.M. on Sunday, July 23, 2000.

This year we are planning on extending the area to include portions of I Street between 10<sup>th</sup> and 12<sup>th</sup>, all of 10<sup>th</sup>, 11<sup>th</sup>, 13<sup>th</sup> between K and I, and portions of 12<sup>th</sup> Street. Please refer to the attached map generated by the City of Modesto to use as a reference. This year we are projecting an attendance of 15,000 people. We are planning to have 75 bands on 8 stages, and a Disco that is three blocks long. We are also planning to do the same

hours and the same clean up plan, since they were successful. We hope to have the event done by 12:00 A.M. after a 4:00 P.M. start time and to have the streets cleared and open by 8:00 A.M.
