BOARD OF SUPERVISORS RESOLUTION

WHEREAS, May 1st is Law Day U.S.A. in the United States of America; and,

WHEREAS, the United States of America has been the citadel of individual liberty and a beacon of hope and opportunity for more than 200 years to many millions who have sought our shores; and,

WHEREAS, the foundation of individual freedom and liberty is the body of the law that governs us; and,

WHEREAS, the Constitution of the United States of America and the Bill of Rights are the heart of that body of the law, which guarantees us many freedoms - including freedom of religious belief, freedom to have and hold property inviolate, freedom of assembly, freedom of speech, freedom of press, freedom of petition, and due process of the law among others; and,
