

ORDINANCE NO. C.S. 758

AN ORDINANCE AMENDING  
NO PARKING ZONES AND TWO HOUR  
PARKING ZONES ON VARIOUS COUNTY ROADS

THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS ORDAINS AS  
FOLLOWS:

**Section 1.** Section 11.08.020 (No Parking at Any Time) of the Stanislaus County Code is hereby amended by adding Subsection 451 (McClure Road), and Subsection 452 (Emerald Avenue) to read as follows:

“451. McClure Road. On the west side of McClure Road from a point 190 feet north of its intersection with Leckron Road, north 220 feet to a point 410 feet north of said intersection.”

“452. Emerald Avenue. On the east side of Emerald Avenue from its intersection with Loletta Avenue, south to a point 150 feet south of said intersection.”

**Section 2.** Section 11.08.060 (Two Hour Parking Zone) of the Stanislaus County Code is hereby amended by adding Subsection 5 (McHenry Avenue) to read as follows:

“5. McHenry Avenue. On both sides of McHenry Avenue from its intersection with Kiernan Avenue (State Route 219), south to its intersection with Claratina Avenue.”

**Section 3.** This ordinance shall take effect 30 days from and after the date of its passage, and before the expiration of 15 days after its passage, it shall be published once with the names of the members voting for and against the same in the Modesto Bee, a newspaper in the County of Stanislaus, State of California.


