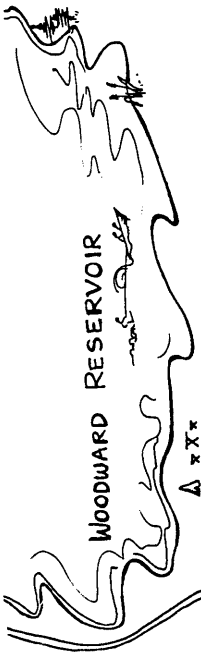

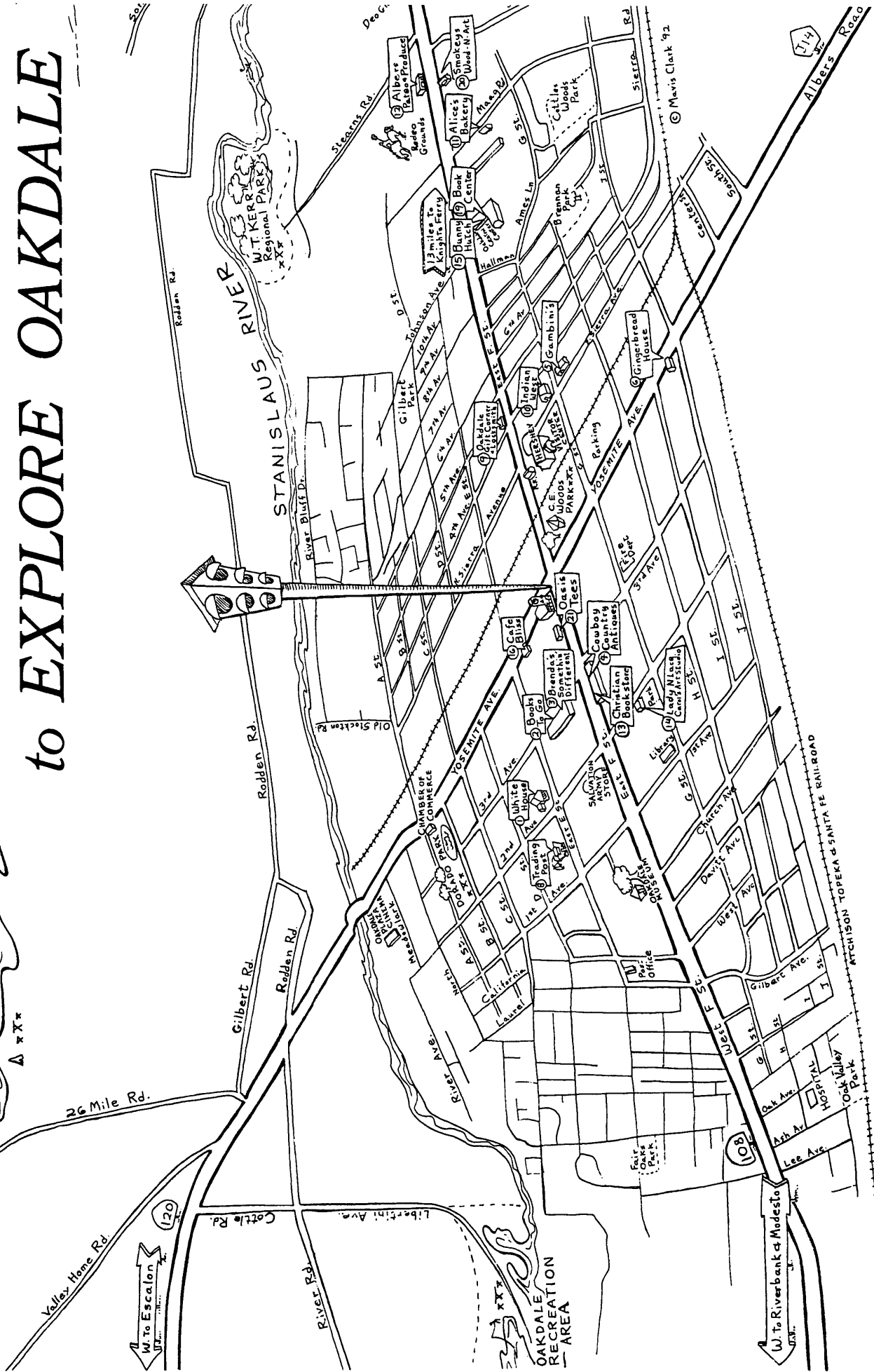
**POLICY
