APPROVAL OF CHILD CARE AND DEVELOPMENT BLOCK GRANT CONTRACT AMENDMENT NUMBER 2 WITH THE CALIFORNIA DEPARTMENT OF EDUCATION. Page 2

DISCUSSION:

In accordance with the California State Budget Act of 2000, the California Department of Education (CDE) and the California Department of Social Services (CDSS) jointly requested authority to spend federal Child Care and Development funds from the FY 2000 grant for Stage 2 services. The additional Stage 2 funding was based on information submitted by contracting agencies through January 2001.

Based on the information submitted by CSA for current caseload, average cost of care, average number of new children per month, children waiting to transfer, children timing out and attrition, it was determined that CSA needed additional funds to fully serve CSA's projected Stage 2 caseload through the remainder of the fiscal year.

Stage 2 funds are used to provide child care services to children whose parents are 1) seeking employment or are enrolled in an employment/training program: 2) employed, 3) recipients of lump sum diversion or 4) to assist Temporary Assistance to Needy Families (TANF) families transitioning off aid. CalWORKs families determined to be stable are moved seamlessly from Stage 1 to Stage 2. A family can continue in Stage 2 for up to 24 months after being discontinued from cash assistance.

The augmentation of \$1,929,380 will increase the total FY 00-01 Stage 2 funding to \$10,557,301. The additional monies will be used to serve an estimated 1,077 Stage II eligible children.

The Agency recommends accepting the contract amendment, which will supplement the existing CDE Child Care and Development Alternative Payments effective July 1, 2000 through June 30, 2001.

POLICY ISSUE:

Approval of the contract amendment supports the Board's priority of economic development by providing child care to recipients who work, and to low-income families who are at risk of becoming dependent on public assistance, and the Board's priority of a safe, healthy community by making child care services available for children who are at risk of abuse and neglect.


