DISCUSSION:

Oakmore Estates Subdivision, Phase 2 is a 13-lot subdivision located on St. Andrews Drive east of Oakdale, California. The final map was approved and filed pursuant to Resolution No. 2000-442, approved by the Stanislaus County Board of Supervisors on June 6, 2000. All improvements required by the Subdivision Improvement Agreement have been constructed to Stanislaus County standards. All Department of Public Works inspection fees have been paid.
