APPROVAL TO ACCEPT OFFICE OF JUVENILE JUSTICE AND DELINQUENCY PREVENTION GRANT IN THE AMOUNT OF \$45,000 FOR THE PURCHASE OF EQUIPMENT AND OFFICER TRAINING; INCREASE REVENUE AND APPROPRIATIONS BUDGET; PURCHASE EQUIPMENT PAGE TWO

DISCUSSION: Grant applicant entitled "ICAC Task Force Program – Stanislaus County, California Investigative Satellite Initiative" has been approved by the U.S. Department of Justice, Office of Justice Programs.

Sheriff's Department will maximize this funding source by providing specialized training, professional development and transportation for the Crimes Against Children and the High-Technology Crimes Investigators assigned to investigate these cases. In addition, specialized computer equipment for undercover operations and forensic evaluations, software, surveillance devices, undercover accounts, Internet service connections, supplies and development of clandestine high-speed connectivity personnel funding will be utilized only to fund overtime considerations where the on-line investigator is faced with contacting suspects outside normal adjusted working hours.
