FISCAL IMPACT:	Block grant funding in the amount of \$181,368 was allocated to Behavioral Health and Recovery Services for fiscal year 2001/2002. In addition, Demonstration Project funding in the amount of \$1,653,500 has been awarded for a demonstration project over a three-year period. The organization will receive \$555,000 for fiscal year 2000/2001; \$550,000 for fiscal year 2001/2002; and \$548,500 for fiscal year 2002/2003. Since the formal award was received in June 2001, the State Department of Mental Health will allow expenditure over a three-year period beginning July 1, 2001. The organization's fiscal year 2001/2002 budget included revenue and expenditures for the first year of the allocation. However, the requested positions were not included in the budget. There is no impact to the County General Fund.

DISCUSSION: Behavioral Health and Recovery Services Older Adult System of Care provides services to individuals with a serious mental illness who are over the age of 60, older adults who are dually diagnosed with a mental illness and substance abuse problem, and individuals on Probate Conservatorship through the Office of Public Guardian.

In November 2000 the Board of Supervisors authorized the acceptance of Federal Substance Abuse and Mental Health Services Administration funding to expand services in the organization's Older Adult System of Care. Funding was used to implement the Senior Access Team and programming was expanded in the following ways:

- Targeted outreach activities were directed toward Spanish-speaking seniors and families, primary care physicians, health care providers, and seniors in independent living. Activities include public informational presentations, depression screening, and the establishment of formal and informal collaborative and referral relationships with health and social service providers.
- Expanded training was developed in skilled older adult behavioral health assessment in order to provide quality, accessible services to older adults.
- The ability to provide senior peer counseling services in English and Spanish was enhanced. A Family and Peer Partnership Project was developed to assist family members or caregivers with necessary advocacy activities for seniors with behavioral health service needs.

Additional funding will allow the organization to further expand the Senior Access Team. Team services will include the following augmented programming in the Older Adult System of Care:

- Direct access to a variety of specialized older adult mental health treatment services.
- Short term case management and linkage of older adults with a serious mental illness to other community resources. This will include assertive follow up and linkage for individuals identified as being "at risk".
- Coordination of multi-agency services for Behavioral Health and Recovery Services older adult clients through use of a Senior Resource Committee and the development of a Mental Health and Aging Advisory Coalition.

• Support of the Senior Network and Advocacy Program (SNAP) to continue outreach activities and to enhance multi-agency collaboration in our community.

Expanded Senior Access Team programming will result in the following outcomes:

Increased access by older adult consumers to primary health care services

90% of Behavioral Health and Recovery Services older adult clients will appropriately access primary health care services

• Reduced indicators of depression in older adult clients

75% of Behavioral Health and Recovery services older adult clients will report a reduction in depression indicators

• Improved social activities with family, friends, neighbors, or other social groups

50% of Behavioral Health and Recovery Services older adult clients will report improvement in this area

• Reduced interference by physical, emotional, or mental health problems in daily activities

50% of Behavioral Health and Recovery Services older adult clients will report improvement in this area

Clients and their families will be satisfied with services offered and received

Client Satisfaction ratings will equal or exceed a rating of 3.4 out of 5

The Stanislaus County Mental Health Board reviewed the grant application and supports the expansion of Older Adult System of Care services.

The Manager II will serve as the Project Coordinator. The Administrative Clerk III will provide clerical support for the project. The Stock Delivery Clerk I/II will provide transportation for project clients. The Mental Health Clinician I/II's and Behavioral Health Specialist I/II's will provide clinical services for project clients.
