#### **DISCUSSION:**

The Community Services Agency (CSA), through Assembly Bill (AB) 1733 currently contracts with local agencies to provide Child Abuse Prevention, Intervention and Treatment Services. Services are administered under the auspices of the Stanislaus Children's Council.

CAPIT legislates a State-funded program to provide intensive, community-based services to victims of abuse. Funding is provided through this agreement with the California Department of Social Services. The agency, with the Board of Supervisor's approval, subcontracts with various agencies to provide these services. Contract providers of CAPIT services are also required to provide an inkind match equal to at least ten percent (10%) of their contract amounts. Historically, providers of CAPIT services contribute far more than their 10% obligated amount.

The services funded through these contracts are based upon the needs established by CSA and the priorities for Stanislaus County as set by the Stanislaus Children's Council. Both funding sources have similar needs/priorities. Current services include:

- Parenting and Counseling Services
- Domestic Violence and Abuse Counseling
- Parental Nurturing
- Respite Care
- Therapy for victims of sexual abuse
- Orientation and placement for victims of abuse
- Hot-line services and a speaker's bureau

The services provided through these contracts are based upon the needs established by CSA and the Interagency Children's Services Coordinating Council. At this time, Request for Proposals have been issued and are due to the purchasing division on July 13, 2001 for funding during the next grant cycle (July 1, 2002 through June 30, 2005).

In order for CSA to receive the funding for Fiscal years 2002 through 2005, the Agency must complete a 'Notice of Intent' indicating that we will be contracting with other agencies to provide us with future CAPIT services.

## POLICY ISSUE:

The Child Abuse Prevention, Intervention and Treatment Services (CAPIT) supports the Board of Supervisor's priority of safe, healthy communities by providing continued services to the children and their families of Stanislaus County who are being abused or at risk of being abused.
