The Stage 2 funds will be used for CalWORKs families determined to be "stable" and moved seamlessly from Stage 1. A family can continue in Stage 2 for up to 24 months after being discontinued from cash assistance. Upon reaching the 24-month time limit a family will "time out" and, if sufficient funding is available, will move seamlessly to Stage 3. As of May 2001, 2,945 families are enrolled in Stage 2.

Stage 3 funds will be used for only those families who have reached the 24 month time limit after being discontinued from cash aid. These families can continue in Stage 3 until the set income limit is reached or all children are 13 years of age. As of May 2001, 302 families are enrolled in Stage 3.

The GAPP contract will be used to provide child care for special at-risk children who are not necessarily CalWORKs, but are linked to the Child Welfare System. As of May 2001, 22 families are receiving child care services for at-risk children.

The total amount of Stage 2 FY 2001-2002 funds is \$12,697,922 which includes \$2,818,997 in state child care alternative payment grant funds, and federal child care alternative payment grant funds of \$9,878,925. Stage 3 FY 2001-2002 funds total \$1,868,734, \$859,515 in state child care alternative payment grant funds and federal child care alternative payment grant funds of \$1,009,219. Overall, these five contracts, totaling \$14,566,656, will allow us to provide child care services to approximately 4,280 children.

The Agency recommends accepting these five CDE Child Care and Development Alternative Payment contracts effective July 1, 2001 through June 30, 2002.





Contractors and subcontractors shall insure that the evaluation and treatment of their employees and applicants for employment are free from such discrimination and harassment. Contractor and its subcontractors shall give written notice of their obligations under this clause to labor organizations with which they have a collective bargaining or other agreement.
- 2. This contractor shall include the nondiscrimination and compliance provisions of this clause in all subcontracts to perform work under the contract.

#### DRUG-FREE WORKPLACE CERTIFICATION

By signing this contract, the contractor hereby certifies under penalty of perjury under the laws of the State of California that the contractor will comply with the requirements of the Drug-Free Workplace Act of 1990 (Government Code Section 8350 et seq.) and will provide a drug-free workplace by taking the following actions:
