APPROVAL TO PURCHASE VEHICLES AND APPROVAL TO TRANSFER TRUST FUNDS. Page 2

DISCUSSION:

The Sheriff's Department Civil Bureau utilizes marked and unmarked vehicles in conjunction with the performance of evictions and the service of civil process and other duties as required. Five vehicles are currently allocated in that detail to perform these functions.

One of the vehicles was recently taken from service as a result of an automobile collision. The Sheriff's Civil Bureau is in need of purchasing vehicles for the purposes of replacing the majority of this fleet.

Government Code Section 26746 provides for a fee to be paid amounting to \$ 5.00 assessment for each disbursement of money collected under various types of civil process. These funds are to be utilized for vehicle fleet replacement and equipment for the Sheriff.

The Sheriff desires to replace the three Civil Bureau cars with 50,000 miles with newly purchased vehicles utilizing civil process fee trust monies. Those displaced Civil Bureau cars will then be transferred to the Sheriff's Operations or Adult Detention Section where the aging, unreliable vehicles will be retired.

County Fleet Services has indicated that the cost for a 2001 Ford Crown Victoria is \$23,720. There are sufficient fees in the Civil Process Fee Trust Fund to cover the indicated costs.
