DISCUSSION:

The Board of Supervisors approved the Community Development Strategic Plan on June 19, 2001. As part of our evaluation, we included a discussion of shortfalls associated with the existing Departmental fee schedule. At the time of approval of the Strategic Plan, the Department indicated that we would bring a revised fee schedule to the Board as soon as possible. This item meets that goal, and proposes an average sixteen percent (16%) increase in all fees charged by the Department for services and discretionary permits.

The public hearing is requested pursuant to Government Code Section 66016 as it relates to proposed fee increases which provides that:

“a local agency shall hold at least one open and public meeting, at which oral or written presentations can be made, as part of a regularly scheduled meeting.”




