DISCUSSION (CONTINUED):

Teen pregnancy is often cited as a cause of economic dependency on the social service system, low birth rate babies and increases in the incidence of child abuse. Teen parents are often unable to complete their education and become self-sustaining, productive members of the community.

Stanislaus County's Health Services Agency has sought to address the teen pregnancy issue through a variety of methods including the provision of family planning services. Nine ambulatory care medical offices located strategically throughout Stanislaus County provide family planning services as defined by Title X and the California State Office of Family Planning. In addition to basic family planning services, the Title X program also requires:

- Adolescent Pregnancy Prevention efforts
- Community advisory participation
- Evaluation of educational materials
- · Chart audits and quality improvement

Although family planning medical office visits are reimbursed at the same level as Medi-Cal, the mandated family planning counseling and education services are not billable. Also, the reimbursement for the more expensive, long-term contraceptive methods is less than the full cost. Further, there is no mechanism to incorporate the cost of service delivery to the community on an outreach basis for substance-abusing women.

HSA was incurring \$486,331 in unreimbursed salary expenses annually to provide the above extra family planning services required but not funded by Title X and \$108,676 annually in unreimbursed contraceptive costs.

As TANF was being implemented in Stanislaus County, HSA's Family Planning staff researched the four purposes of TANF. Purpose number three is, "To prevent and reduce the incidence of out-of-wedlock pregnancies and establish numerical goals for preventing and reducing the incidence of these pregnancies. Under this purpose, HSA staff recognized an opportunity to enter into a collaborative Inter-Agency Agreement with the Stanislaus County Community Services Agency (CSA) to expand and enhance our family planning program and offset unreimbursed costs through TANF funds.

DISCUSSION (CONTINUED):

In July of 2000, the Board of Supervisors approved this innovative approach to expanding family planning services in the County though a contractual agreement with the Community Services Agency to expend CalWORKS incentive monies for the Family Planning Outreach Program. Stanislaus County was the first county in California to use TANF funds for family planning services. Providing these services at non-traditional family planning sites, such as our nine medical offices, has further encouraged patients to access services.

The Inter-Agency Agreement transferred \$203,998 from CSA TANF funds to HSA. Our goal was to increase access to family planning services county-wide with special attention to the communities of Waterford, Oakdale, Riverbank, Patterson, and Newman. Our objectives included a 10% increase in services and a 5% increase to male clients based on the current California Department of Health Service's report of unmet needs. We were able to meet this goal within the first six months of the program by expending only 50% of the contract award.

DISCUSSION (CONTINUED):

Updated teen pregnancy rates for the period of this grant will not be available from the State until January 2002. As reported in April in the Agency's Community Health Report Card, the teen pregnancy rate continues to decline in Stanislaus County and Statewide. This encouraging trend is due to many factors including increased partnerships in the communities throughout the County, increased availability of services, and families involved in addressing teen pregnancy.

HSA estimates that each teen pregnancy that is averted results in savings to the health system of \$872.98. There is a saving of \$5.85 for medical costs incurred per dollar spent on contraception. We estimate that \$50,000 spent on the Family Planning Outreach Program has resulted in over \$300,000 in total medical costs saved. Our outreach efforts have expanded to non-county providers serving pregnant teens as well as to family planning education being incorporated into TANF recipient orientations. Through presentation of this solution to other counties, we have heard that many other California counties are now considering or have already implemented this solution themselves.

POLICY ISSUES:

Approval by the Board of Supervisors supports the Board priorities of a safe, healthy community, community service delivery, and multijurisdictional cooperation.
