# ORDINANCE NO. C.S. 773

### AN ORDINANCE AMENDING NO PARKING ZONES AND NO TRUCK PARKING ZONES ON VARIOUS COUNTY ROADS

THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS ORDAINS AS FOLLOWS:

Section 1. Section 11.08.020 (No Parking at Any Time) of the Stanislaus County Code is hereby amended by adding Subsection 453 (Toomes Road), Subsection 454 (Kiernan Avenue), Subsection 455 (Crystal Avenue), Subsection 456 (Church Street), Subsection 457 (Paradise Road) and Subsection 458 (Sisk Road) to read as follows:

"453. Toomes Road. On the east side of Toomes Road from its intersection thereof with Kiernan Avenue north to its intersection with Ciccarelli Road; and, on the west side of Toomes Road from its intersection thereof with Kiernan Avenue north to a point 165 feet from said intersection; and, on the west side of Toomes Road from a point 345 feet north of its intersection with Kiernan Avenue, north 175 feet to a point 520 feet north of said intersection; and, on the west side of Toomes Road from a point 645 feet north of its intersection with Kiernan Avenue north to its intersection with Ciccarelli Road."

"454. Kiernan Avenue. On the north side of Kiernan Avenue from its intersection thereof with Toomes Road, west to a point 115 feet from said intersection; and, on the north side of Kiernan Avenue from a point 215 feet west of its intersection with Toomes Road, west 95 feet to a point 310 feet west of said intersection; and, on the north side of Kiernan Avenue from a point 740 feet west of its intersection with Toomes Road, west 100 feet to a point 840 feet west of said intersection; and, on the north side of Kiernan Avenue from a point 920 feet west of its intersection with Toomes Road, west 60 feet to a point 980 feet west of said intersection; and, on the north side of Kiernan Avenue from a point 1,245 feet west of its intersection with Toomes Road, west 60 feet to a point 1,305 feet west of said intersection; and, on the north side of Kiernan Avenue from its intersection thereof with Toomes Road Ordinance No. C.S. 773 An Ordinance Amending No Parking Zones And No Truck Parking Zones on Various County Roads Page 2

east to a point 900 feet from said intersection; and, on the south side of Kiernan Avenue from its intersection thereof with Toomes Road east to a point 100 feet from said intersection; and, on the south side of Kiernan Avenue from its intersection thereof with Toomes Road west to a point 310 feet from said intersection."

"455. Crystal Avenue. On the east and west sides of Crystal Avenue from its intersection thereof with Hatch Road, north to a point 100 feet from said intersection; and, on the west side of Crystal Avenue from its intersection thereof with Glacier Avenue north and south to a point 100 feet from said intersection; and, on the east and west sides of Crystal Avenue from its intersection thereof with Crater Avenue south to point 100 feet from said intersection."

"456. Church Street. On the east side of Church Street from its intersection thereof with Northland Drive to a point 50 feet north and south from said intersection."

"457. Paradise Road. On the northerly side of Paradise Road from a point 100 feet easterly of its intersection thereof with Pine Tree Lane, easterly 140 feet to a point 240 feet from said intersection."

"458. Sisk Road. On the west side of Sisk Road from its intersection thereof with State Route 219 (Kieman Avenue), north to a point 90 feet from said intersection."

Section 2. Section 11.08.020. (No Parking At Any Time) of the Stanislaus County Code Subsection 103 (Ninth Street) is hereby amended to read as follows:

"103. Ninth Street (Modesto). On the west side of Ninth Street from its intersection with Pecos Avenue south to point 100 feet south of said intersection; and, on the west side of ninth street from a point 270 feet south of its intersection with Pecos Avenue, south 75 feet to a point 345 feet south of said intersection."

Section 3. Section 11.08.120 (No Truck Parking) of the Stanislaus County Code is hereby amended to add subsection 8 (Pirrone Road) to read as follows:

"8. Pirrone Road. On the westerly side of Pirrone Road from its intersection thereof with Pirrone Court, northerly to a point 725 feet from said intersection."

Section 4. This ordinance shall take effect 30 days from and after the date of its

passage, and before the expiration of 15 days after its passage, it shall be published once with the

names of the members voting for and against the same in the Modesto Bee, a newspaper in the

County of Stanislaus, State of California.

ORDINANCE NO. C.S. 773 AN ORDINANCE AMENDING NO PARKING ZONES AND NO TRUCK PARK-ING ZONES ON VARIOUS COUNTY ROADS THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS ORDAINS AS FOL-LOWS:

Section 1. Section 11.08.020 (No Parking at Any Time) of the Stanislaus County Code is hereby amended by adding Subsection 453 (Toomes Road), Subsection 454 (Klernan Avenue), Subsection 455 (Crystal Avenue), Subsection 456 (Church Street), Subsection 457 (Paradise Road) and Subsection 458 (Sisk Road) to read as follows: \*453.

Toomes Road. On the east side of Toomes Road from its intersection thereof with Klernon Avenue north to its intersection with Ciccarelli Road; and, on the west side of Toomes Road from its intersection thereof with Kiernan Ave-nue north to a point 165 feet from said intersection; and, on the west side of Toomes Road from a point 345 feet north of its intersection with Kiernan Avenue, north 175 feet to a point 520 feet north of sold intersection; and, on the west side of Toomes Road from a point 645 feet north of its intersection with Kiernan Avenue north to its intersection with Ciccarelli Road." 454.

Kiernan Avenue. On the east and west sides of Crystal Avenue from its intersection thereof with Hatch Road, north to a point 100 feet from said intersection; and, on the west side of Crystal Avenue from its intersection thereof with Gla-cler Avenue north and south ta a point 100 feet from said intersection; and, on the east and west sides of Crystal Avenue from its intersection thereof with Crater Avenue south to point 100 feet from said intersection.=456. Church Street. On the east side of Church Street from its intersection thereof with Northland Drive to a point 50 feet north and south from said intersection.\* \*457.

Paradise Road. On the northerly side of Paradise Road from a point 100 feet easterly of its intersection thereof with Pine Tree Lane, easterly 140 feet to a point 240 feet from said intersection." \*458. Sisk Road. On the west side of Sisk Road from its intersection thereof with State Route 219 (Kiernan Avenue), north to a point 90 feet from sold intersection.

Section 2. Section 11.08.020. (No Parking At Any Time) of the Stanislaus County Code Subsection 103 (Ninth Street) is hereby amended to read as follows:

103. Ninth Street (Modesto). On the west side of Ninth Street from its intersection with Pecos Avenve south to point 100 feet south of said intersection: and, on the west side of ninth street from a point 270 feet south of its intersection with Pecas Avenue, south 75 feet to a point 345 feet south of said intersection.\*

Section 3. Section 11.08.120 (No Truck Parking) of the Stanislaus County Code is hereby amend-

ed to add subsection 8 (F\* mone Road) to read as follows:

"8. Pirrone Road. On the westerly side of Pirrone Road from its intersection thereof with Pirrone Court, northerly to a point 725 feet from said intersection.\*

ed to add subsection 8 (fi 'rone Road) to read as follows:

\*8. Pirrone Road. On the westerly side of Pirrone Road from its intersection thereof with Pirrone Court, northerly to a point 725 feet from said intersection.\*

Section 4. This ordinance shall take effect 30 days from and after the date of its passage, and before the expiration of 15 days after its passage, it shall be published once with the names of the members voting for and against the same in the Modesto Bee, a newspaper in the Caunty of Stani slaus, State of California.
