The Advisory Boards for Drug Programs (BD16) and Alcohol Problems (BD05) were combined on 3/16/93 in Board of Supervisors Resolution

#93-300.

MEMBERSHIP: The Board consists of no fewer than 15, and no more than 20 members,

appointed by Board of Supervisors.

QUALIFICATION: The Board will include persons who have a professional interest in or AND RESIDENCY personal commitment to alleviating problems related to drug abuse and inappropriate alcohol use in the community. As feasible, there shall be a

least two and no more than four members from each Supervisorial District. Membership shall also include one representative each of Modesto Police

Dept, Stanislaus County Sheriff, and California Highway Patrol as

standing members.

TERM: 3 Year Term with two term limitation

DUTIES: The Advisory Board advises the Board of Supervisors on policies and

goals of the County alcohol and drug programs. Encourages and educates the public to understand the nature of alcohol and drug abuse problems and supports the development and implementation of effective programs. Reviews the community's programs needs, services, facilities and special programs. Insures public input in the formation and adoption of the

county's programs and master plan.
