Dear Members of the Board:

As required by Proposition 10, in 1999 the Stanislaus County Board of Supervisors adopted an ordinance establishing the Stanislaus County Children and Families Commission as an appointed nine-member body. The ordinance establishing the Commission, Ordinance #687, contained criteria for Commission membership.

As codified in Section 9.70.050 of the Stanislaus County Code, two of the members of the Commission are to be County department heads from Behavioral Health and Recovery Services or the Community Services Agency or the Health Services Agency. Currently, Denise Hunt from BHRS and Ken Patterson from CSA serve as Commissioners.

As you know, Ken Patterson has resigned from his position as the head of CSA effective November 9, 2007. It is recommended that the Board of Supervisors take action as soon as practical after November 9<sup>th</sup> to appoint Mary Ann Lee, the head of HSA, or the Interim CSA Director (who has yet to be named) as a Children and Families Commissioner. Ms. Lee has indicated a willingness to be appointed to the Commission.
