## **DISCUSSION:**

County ordinance currently provides four hours holiday time when Christmas Eve falls on a weekday.

Section 3.48.010, reads: Employees shall be entitled to the following holidays: Four hours when Christmas Eve falls on any day of the week except Saturday or Sunday. Employees required to work full shifts, including Saturday or Sunday, on Christmas Eve shall be credited with four hours of vacation time.

Christmas Eve falls on Monday this year. County offices will be closed the following Tuesday, December 25, 2007. Employees required to work on Monday, December 24, 2007, will receive 4 hours of holiday credit pursuant to the applicable MOU. All holiday provisions in the MOU's that apply to this holiday will remain in effect.

If approved by the Board of Supervisors, all County Offices not required to work to meet State Mandate responsibilities, the provision of essential local services, or required to address other exigent circumstances will be afforded the opportunity to utilize vacation time or compensatory time off in lieu of working their normal shifts. Employees without vacation or compensatory time off balances would be required to report to work and fulfill their normally assigned duties. Employees not wishing to utilize vacation or compensatory time off for the half-day period will report to work in their normally assigned duties.

As with all County holidays and other office closures, Department Heads will be responsible to determine if staff will be retained to meet local needs or state mandate requirements. Further, in departments in which employees choose to work rather than exercise the option of using vacation or compensatory time off, Department heads will be responsible to assign adequate supervisory staff.

## **POLICY ISSUE:**

Approval of this request will provide many County employees the option to work their assigned shift or to take vacation or compensatory time off to spend additional time with family. While approval of this request will reduce access to public services between 8:00 AM and 12:00 PM on December 24, 2007, this four hour period has traditionally seen extremely limited activity.

## **STAFFING IMPACT:**

There is no impact on staffing resulting from this change.
