#### SUBJECT:

Approval to Accept the Fiscal Year 2007-2008 Grant from the Department of Insurance for District Attorney's Office Workers' Compensation Fraud Program and Adjust the Budget

#### STAFF RECOMMENDATIONS:

- 1. Accept Fiscal Year 2007-2008 Grant from Department of Insurance for District Attorney's Office Workers' Compensation Insurance Fraud Program totaling \$260,000.
- 2. Authorize the DA to sign the grant award agreement including any extension, or amendments.
- 3. Approve a formal resolution as required by the State to receive this grant funding.
- 4. Direct the Auditor-Controller to decrease appropriations and estimated revenue by \$35,804 consistent with the budget journal.

#### FISCAL IMPACT:

Projected revenues and expenditures for this grant totaling \$321,012 were reflected in the Fiscal Year 2007-08 final budget process. The actual expenditures and revenues will be less than budgeted. After the budget submittal, it was decided by the DA to have the prosecutor and investigator spend less time on the Worker's Compensation cases due to being needed in more critical areas. The paralegal will continue to be funded for 65% of her time by the grant. A modified budget was submitted to the DOI for the new salary expenditures and the carryover amount of \$25,208 from FY 2006-07. The modified budget was accepted by the DOI. Total funding for the grant will be \$285,208. (continued page 2)

## FISCAL IMPACT:

It is requested that the budget be decreased by \$35,804 for this fiscal year to reflect the final grant funding award and the carry over revenue from the previous year. There is no County Match with this grant.

## DISCUSSION:

Insurance fraud affects the citizens of Stanislaus County through increased insurance rates. The District Attorney's Office is committed to the aggressive prosecution of those who commit insurance fraud, and the acceptance of the Department of Insurance's Workers' Compensation Fraud Prosecution grant has allowed this aggressive prosecution to occur. This agenda item is being submitted for Board approval to authorize the District Attorney to accept the grant funding and adjust the budget. A formal resolution is attached.

The Workers' Compensation Fraud unit provides aggressive prosecution against those who knowingly commit fraud against the system whether they are County or private employees, professional, medical and legal providers, employers, or insurance company representatives. For Fiscal Year 2007 – 2008, the tenth year of funding, \$260,000 in funding was awarded and the carry over amount of \$25,208 will be utilized. The total amount of \$285,208 will be a decrease of \$35,804 under the legal budget amount.

Due to workload issues and funding restraints, most of the Paralegal's time will be dedicated to this grant and the remaining amount of her time will be dedicated to the Automobile Insurance Fraud Unit. The Attorney and Investigator will work a portion of their time to this grant and both will record their time accordingly in order to charge their salary expenses to this unit.

Funding in this amount, according to current projections for salaries and benefits should be sufficient to cover the cost of the assigned employees for Fiscal Year 2007-2008. Any remaining funds will be used to cover the cost of training and travel unique to the Workers' Compensation Unit Staff and the cost of the mandated program audit. The District Attorney's Office will cover the operating costs and equipment expenses for this grant. The District Attorney's Attorney's Office is committed to maintaining this budget within the authorized grant funding allocation.

### **POLICY ISSUES:**

Acceptance of this grant will assist the District Attorney's Office in meeting the Board's goal of a safe, healthy community.

### **STAFFING IMPACTS:**

There are no staffing impacts at this time.
