DISCUSSION:

On May 8, 2007, the Board of Supervisors authorized the Director of the Department of Environmental Resources (Department) to apply for and receive the 2007/2008 non-competitive Discretionary Household Hazardous Waste Grant (HD16c) provided by the California Integrated Waste Management Board (CIWMB).

The HD16c grant funds will be utilized to improve the Household Hazardous Waste facility's operation to accommodate the increased volume of universal and sharps waste. The grant funds will also be utilized to increase public awareness and participation in the recycling programs for these waste streams.

At the time of the grant application, the grant amount was estimated to be \$7,000 and the term of the grant agreement was anticipated to be from September 2007 through February 2009. On October 25, 2007, the CIWMB notified the Department that the actual grant amount would be \$7,099 and the term of the agreement would be October 1, 2007, through June 30, 2009. The grant agreement is included as Attachment "A."

POLICY ISSUES:

The Board of Supervisors should determine if accepting these additional grant funds and correcting the term of the grant is consistent with the Board's priorities of a safe community, a healthy community and the efficient delivery of public services.

INTRODUCTION

Regulations to protect public health and the environment have been changing. We now know that some common items that have traditionally been thrown in your household or small business's trash cannot be safely disposed in landfills. These common items are referred to as hazardous waste, and some of them as "universal waste" (u-waste). As of February 9, 2006, homeowners and very small businesses, which were exempted from the u-waste disposal banned, no longer are. Some examples of universal waste include:

- Batteries
- Fluorescent tubes (lamps) and High Intensity Discharge (HID) Lamps
- Electronic devices (cell phones, computers, televisions)
- Cathode ray tubes (CRTs) (computer monitors, televisions)
- Mercury wastes (thermometers and toys)
- Non-empty aerosol cans

The population in Stanislaus County has increased by 19.5% from 1996 to 2006. As a result, Household Hazardous Waste collection (HHW) in Stanislaus County has increased steadily. In addition, there has been a 10% increase in HHW brought to our facility during Fiscal Year 2004/2005.

Stanislaus County has operated a HHW Collection Program since 1992. The County maintains a permanent collection facility at 1716 Morgan Road, Modesto, for residential and small business customers, and provides mobile collection services to many of the cities within the County. HHW collections services are funded by a surcharge on refuse deposited at the City and County Waste-To-Energy facility.

The County is proposing to apply and obtain grant funds to help promote and expand the types and amounts of u-waste collected at our HHW facility and other pre-approved collection sites. These other collection sites may include partnerships with retail businesses such as home improvement stores, cell phone stores and pharmacies.

If the department were successful in obtaining the competitive Infrastructure Grant, it would be able to purchase sharps (syringes and needles) containers for home-generated sharps and increase advertisement of the acceptance of home-generated sharps. The home-generated sharps would be accepted at our HHW facility and at participating pharmacies. According to the <u>Center for Disease</u> <u>Control</u> there are 11.1 million diabetes sufferers in the United States and it estimates that another 6 million cases are undiagnosed. There are over 18,000 diabetics within Stanislaus County that could produce home-generated sharps.

In addition, the competitive Infrastructure Grant funds will also help expand the Countywide U-waste (household batteries, fluorescent tubes, and mercury thermometers) Collection Program. Funds would be used to increase public awareness of the environmental and health concerns posed by u-waste and the availability of u-waste collection sites. As of February 9, 2006, fluorescent tubes along with batteries from residences are no longer allowed to be disposed of as solid waste and must be handled as hazardous waste.

An objective to increase u-waste collection sites throughout the County would be to partner with businesses that sell household batteries and fluorescent tubes to allow easier access for these home-generated wastes. Battery-recycling containers and fluorescent tube-recycling containers would be purchased with grant funds and distributed to businesses and made available for customers. The customers would be encouraged to bring their old batteries and fluorescent tubes for recycling when they go to purchase new ones.


<u>1. NEED</u>

HHW collection services are currently provided through the County's permanent HHW facility and 7 temporary HHW collection locations. Temporary collections are set up in surrounding cities within Stanislaus County. They are located in Turlock, Waterford, Oakdale, Riverbank, Patterson, Newman, and Hughson. The hours of operation are Fridays and Saturdays from 9 am to 1 pm (See map for HHW locations). Combined they give County residents 15 different locations to drop off household hazardous waste.

Electronic/Universal Waste (U-Waste) is the most rapidly growing segment of the municipal waste stream. U-waste is a general category of electronic products including fluorescent tubes, batteries, cathode ray tubes (CRT's), mercury gauges and electronic devices. U-Waste now makes up 5 percent of all municipal waste worldwide. According to the International Association of Electronics Recyclers, Americans dispose of 2 million tons of electronic products a year including 50 million computers and 130 million cell phones. By 2010, the United States will be discarding 400 million electronic units annually. In addition, some researchers estimate that nearly 75 percent of old electronics are in storage, in part because of the uncertainty of how to manage the materials.

Currently, electronic items are sold in California and Stanislaus County in great numbers. Although the length of time between purchase and disposal is difficult to predict, it is certain that increasing sales through 2006 will yield continued high volumes of u-waste in the coming decades. Combine this with increasing advances in technology and new products headed towards the market and it is no wonder that u-waste disposal has become a popular topic. All current studies¹ show a gap exists between the existing processing capacity and the projected volume of u-waste for Stanislaus County for 2006. The capacity shortfall reflects a difference of thousands of tons of u-waste and the millions of dollars in additional cost to process that waste. Additionally, the absence of convenient diversion outlets seriously bottlenecks the flow of u-waste to secondary processors. At this time, no private local collection programs are considering expanding their efforts into the u-waste diversion market because of high handling and transportation costs.

For the County's public out-reach program, the County each year prints up and hands out our HHW flyer to local city governments, recycling centers, and the landfills. The flyer, printed in English and Spanish, contains the year's permanent and temporary HHW locations and times. The flyer also informs residents on the types of waste they may bring. It also includes a 24-hour HOT LINE that provides additional recycling and disposal information. In the past, only 25,000 HHW flyers were distributed.

To increase our public out-reach program, the County inserted our HHW flyer into the Modesto Bee. The HHW was also inserted into the Spanish newspaper Vida en el vale, and inserted into resident's mailboxes that do not subscribe to the newspaper. An estimated 230,152.00 households received our 2004 HHW flyer. As a result, the County has seen a noticeable increase in its weekly totals for customer participation.

U-Waste collection services are currently only provided at the County's Permanent U-Waste Collection Facility, located at 1716 Morgan Road in Modesto. Since its implementation in January 2006, the u-waste Facility has collected over 55,000 pounds of CRT's and u-waste. Waste that has been diverted in such a way that it does not enter the solid waste stream (i.e., landfills-where toxic substances, such as lead, mercury, cadmium can leach into the ground and impact air and water quality). The collection facility is open Friday and Saturday 9 a.m. to 1 p.m., excluding major holidays and is free of charge to the residents of Stanislaus County. Smaller businesses within the County can also use the Collection facility.

Although the County u-waste program is a success it could benefit from more collection opportunities. With the implementation of new diversion opportunities residents will be encouraged to deplete their stockpiles and assure that the growing waste flow of end-of-life electronic products is managed in a way that protects public health and the environment and conserves resources. The bottom line is that we must keep hazardous materials out of the trash by bringing them somewhere to be recycled or safely disposed, such as the Stanislaus County U-Waste collection facility.

2. GOALS AND OBJECTIVES

The primary goal is to use grant monies to develop grassroots collection system at the local level, that is, a system that combines a large-scale u-waste collection and diversion program that maximizes protecting the public health and environment while conserving natural resources. To do this we plan to partner with local businesses to become the goodwill ambassador for the community, collecting u-waste at their retail facilities.

3. WORK PLAN

Since the operation of the HHW facility in 1992, the amounts of household hazardous waste collected has increased at a steady rate.

Goal 1: Initiate take back programs with local businesses

- Activity A: Contact headquarters of targeted major retail stores in our County to explain the Take Back Program.
- Activity B: Contact local managers of retail stores to implement the take back program after the approval of its headquarters.
- Activity C: Initiate a sharps container exchange program. The County is planning to establish a partnership with local pharmacies to take back full sharp containers from customers. The empty sharp containers will be provided to the pharmacies will be purchased by the grant funds.
- Activity E: Establish a community wide outreach program regarding uwaste and sharp waste handling and disposal.
- The County's goal to reach the rural, less populated area in the County with our HHW flyer will be implemented by the continued increase in advertisement and flyer handouts. The County's current ability to reach 230,152 households through inserts into newspapers and mail outs represents an 88% increase in the number of County residents that receive our HHW flyer. The cost to reach such a high number of households, with the supporting advertisements is high. The current annual cost for production, distribution, and advertising the County's HHW flyer is \$29,000.

Goal 2: Increase HHW participation from smaller communities within Stanislaus County.

- Activity A: During temporary mobile events and local events, pass out HHW brochures about safe ways to dispose of hazardous waste, u-waste and sharps.
- Activity B: Provide the list of participating businesses in the Take Back Program for batteries and fluorescent lamps to households and all interested parties.
- Activity C: Increase advertisement and notices of universal and sharp waste issues in local newspapers.

Community-based social marketing has not been performed in the past few years by Stanislaus County. With the rise in disposal cost, wages, and the lack of revenue, the County's HHW budget is extremely limited to paying for labor, supplies, and disposal. Community-based social marketing is something the County is striving to do, but currently has insufficient funds to implement.

4. EVALUATION

HHW questionnaires will be handed out to all customers who come to our permanent and temporary HHW collection events. The questionnaire will focus on the participant's address, how often they use the services, what waste types they are bringing and how they heard about the program. In addition we will keep records on the types amounts of u and e-waste being collected and recycled. The information collected will be placed into a database where all the pertinent information can be recorded and evaluated. The Department's clerical staff will be in charge of the entering the data into the database and the Hazardous Material Specialist will evaluate the information. The data collected will provide for future changes to advertisement, community based marketing, and overall customer service.

5. BUDGET

The budget itemization cost breakdown lists the complete cost for the abovementioned programs. The cost breakdown shows the cost for the u-waste, sharps container exchange program, and advertisements. The proposal is cost effective and reasonable to the task required.

6. COMPLETENESS, LETTERS OF SUPPORT

DER will be responsible for the implementation and the operation of the project. DER has extensive experience conducting HHW collection programs and has trained and skilled staff to plan and execute HHW collection programs. DER has operated a highly successful HHW collection program since 1992. The project will be the increase in waste collection by the existing permanent HHW facility located at 1716 Morgan Road Modesto, CA 95355.

Attached are letters of support from other cities within the County who support the County's need to expand its HHW facility and to continue producing the HHW flyer for the County's residents.

7. EVIDENCE OF A RECYCLED-CONTENT PURCHASING POLICY

The Stanislaus County Board of Supervisors has adopted a recycled content purchasing policy. The County uses recycled paper in many of its programs, including those of the Department of Environmental Resources. A copy of the County's policy is attached to Exhibit G.

8.NEW PROGRAM FOR HHW COLLECTION IN RURAL AREAS

The project greatly expands the County's u-waste collection service for all the residents within the County through alternative collection locations. With added public awareness through advertisements and mail outs, approximately 230,152 households should be reached within the County. The use the u-waste flyer along with retail outlets as collection locations will allow for greater saturation and increased opportunity for rural residents to recycle their u-waste.

9.UNDERSERVED POPULATIONS

The proposal greatly expands the County's u-waste collection through a community effort. With added advertisement and distribution of a proposed County u-waste awareness flyer distributed through various media outlets, approximately 230,152 households should be reached within the County. The use of the u-waste flyer, along with retail outlets as collection locations, will allow for greater saturation of the undeserving areas ability to recycle their u-waste.

10. ESTABLISHES MULTI-JURISDICTIONAL HHW PROGRAMS

The Cities and County's HHW program is a multi-jurisdictional program which includes all 9 incorporated cites. The program was designed to serve the HHW handling and disposal needs for all County residents and small businesses. The program has one centrally located permanent collection facility and various temporary collection events throughout Stanislaus County. The grant money will allow for an increase of the household hazardous waste, u-waste and sharps collection and public education. This project will undoubtedly serve the regional needs of the County and provide a valuable service to the residents of Stanislaus County.

11. HHW GRANT

The County did not receive a household hazardous waste grant award during the HD 14 (FY 2005-2006) grant cycle.

12 RECENT HHW GRANT AWARDED

The County received household hazardous waste grant award during the HD 13 (FY2004-2005) grant cycle.

Environmentally Preferable Practices: An Overview

Purchasing recycled-content and other environmentally preferable products creates markets for the materials that state and local governments divert in complying with Assembly Bills 939 and 75. If these diversion efforts are to be successful, adequate markets must exist for the diverted material. It is arguable that no better market development tool exists than purchasing environmentally preferable products that contain diverted materials. In addition, environmentally preferable product purchasing and practices reduces the amount of waste being generated in the first place, reduces natural resources consumption, saves water, energy, and landfill space, and improves air quality.

To help ensure a healthy environment through healthy markets for EPPs, at the June 18-19, 2002 meeting the Board approved revisions to the Grant Scoring Criteria to reflect "Evidence of a Recycled-Content Purchasing Policy or Directive" in competitive grant applications.

Relevant Public Contract Code Sections

Public Contract Code (PCC) 12210: All local and state public agencies shall purchase recycled products instead of non-recycled products, so long as price, quality, and availability are comparable.

PCC 12205: On and after January 1, 2000 at least fifty percent (50%) of State purchases are required to be recycled products.

PCC 12213: All public agencies shall require the bidder to certify the amount of recycled material in all products. No product manufactured with postconsumer or secondary material shall be discriminated against for reason other than function. Recycled-content products are to be preferred over non-recycled-content products.
