Approval to Adopt Plans and Specifications for the Pirrone Road Canal Crossing Project and Set the Bid Opening Date and Time for January 23, 2008, 2:00 P.M.

DISCUSSION:

The Pirrone Road Project is part of the original Salida Community Plan. The Salida Community Plan was approved in December 1988 and encompassed approximately 700 acres of land. The plan included a mix of land uses, including residential, commercial, industrial, and public lands for schools, neighborhood parks and storm drainage facilities.

Modesto Irrigation District (M.I.D.) requires that canal construction be completed by March 15, 2008. Due to canal construction timing limitations, the Pirrone Road Project was separated into two phases. Phase 1 is the Pirrone Road Improvement Project and Phase 2 is the Pirrone Road Canal Crossing Project.

The limits of the Pirrone Road Canal Crossing Project shall be 50 feet south of the M.I.D. lateral to 375 feet north.

The Pirrone Road Canal Crossing Project will consist of overlaying a segment of Pirrone Road with asphalt concrete, pavement and irrigation structure widening, and constructing concrete curb, gutter, and sidewalk.

A master Environmental Impact Review (E.I.R.) was completed in 1989 by the Planning and Community Development Department as required by the California Environmental Quality Act (CEQA).

The Salida Municipal Advisory Council was notified by the Director of Public Works that the Pirrone Road Project was going before the Board of Supervisors for adoption.

The project is anticipated to begin construction in February 2008 and end April 2008.

POLICY ISSUES:

The Board should consider if the recommended actions are consistent with its priorities of providing a safe community, a healthy community and a well-planned infrastructure system.

STAFFING IMPACT:

There is no staffing impact associated with this item.





GRADING NOTES:

- ALL GRADING SHALL BE IN ACCORDANCE WITH THE REQUIREMENTS OF THE ALL GRADING SHALL BE IN ACCURUANCE WITH THE RECOMPLETENCE OF THE STANISLAUS COUNTY DEPARTMENT OF PUBLIC WORKS STANDARDS AND SPECIFICATIONS, 5. PAVEMENT MARKINGS SHALL BE FIELD REVIEWED BY THE STANISLAUS COUNTY TRAFFIC EDITION), AND THE GEOTECHNICAL SERVICES REPORT.
- 2. CONTRACTOR SHALL COORDINATE WITH RESPECTIVE UTILITIES TO REMOVE OR RELOCATE ALL EXISTING UTILITY POLES IN CONFLICT WITH PROPOSED IMPROVEMENTS.
- 3. THE CONTRACTOR SHALL REMOVE AND DISPOSE OF ANY AND ALL UNSUITABLE FILL MATERIAL FROM THE SITE IN ACCORDANCE WITH APPLICABLE LAWS, AND ORDINANCES. REMOVAL OF SAID MATERIAL SHALL BE INCLUDED IN THE VARIOUS CONTRACT PRICES PAID FOR IN THE OWNERS/CONTRACTORS CONSTRUCTION CONTRACT. NO ADDITIONAL COMPENSATION SHALL BE MADE UNLESS OTHERWISE OWNER APPROVED BY CHANGE
- 4. THE CONTRACTOR SHALL BE HELD RESPONSIBLE FOR ANY FIELD CHANGES MADE WITH WRITTEN AUTHORIZATION FROM THE ENGINEER.
- . WHENEVER EXISTING FACILITIES ARE DAMAGED, BROKEN AND/OR CUT IN THE INSTALLATION OF THE WORK COVERED BY THESE SPECIFICATIONS, SAID FACILITIES SHALL BE REPLACED AT THE CONTRACTOR'S EXPENSE, AFTER PROPER BACKFILLING AND/OR CONSTRUCTION WITH MATERIALS EQUAL TO OR BETTER THAN THE MATERIALS USED IN THE ORIGINAL EXISTING FACILITIES. THE FINISHED PRODUCT SHALL BE SUBJECT TO THE APPROVAL OF STANISLAUS COUNTY AND THE PROJECT ENGINEER.
- 6. AN APPROVED SOIL STERILANT SHALL BE APPLIED TO ALL STREET SUB-GRADE SURFACES PRIOR TO CONSTRUCTION.

DEMOLITION NOTES:

1. ALL WELLS, SEPTIC TANKS AND LEECH LINES LOCATED DURING THE COURSE OF CONSTRUCTION SHALL BE REMOVED IN ACCORDANCE WITH THE REQUIREMENTS OF STANISLAUS COUNTY HEALTH DEPARTMENT AND APPLICABLE GROUNDWATER PROTECTION ORDINANCES. THIS WORK SHALL BE INCLUDED AS PART OF THE DEMOLITION COST. A PERMIT FOR WELL DESTRUCTION SHALL BE OBTAINED FROM THE STANISLAUS COUNTY HEALTH DEPARTMENT.

DUST CONTROL

- 1. ALL EXPOSED SURFACES SHALL BE WATERED A MINIMUM OF TWICE DAILY UNLESS DEEMED UNNECESSARY DUE TO WEATHER. WATER SHALL BE APPLIED AS PROVIDED IN SECTION 17 OF CALTRANS STANDARD SPECIFICATIONS.
- 2. DUST PALLATIVES MAY BE SUBSTITUTED FOR WATERING UPON THE APPROVAL OF THE ENGINEER. DUST PALLATIVES SHALL BE APPLIED AS PROVIDED IN SECTION 18 OF CALTRANS STANDARD SPECIFICATIONS.
- 3. ALL TRUCKS CARRYING LOOSE MATERIALS SHALL BE COVERED WITH A TARPAULIN.
- W/STANISLAUS COUNTY, MODESTO IRRIGATION DISTRICT AND ALL RESPECTIVE UTILITY 4. ALL EXPOSED EARTH SURFACES SHALL BE PLANTED AT THE EARLIEST POSSIBLE TIME.

EXISTING UTILITIES

- 1. ALL EXISTING MANHOLE RIMS, VALVE BOXES, MONUMENTS, VAULTS, AND OTHER UTILITIES IN THE RIGHT-OF-WAY SHALL BE ADJUSTED TO FINISH GRADE AFTER STREET PAVING. COST FOR RAISING FACILITIES TO BE INCLUDED IN UNIT PRICE FOR PAVING.
- 2. CONTRACTOR SHALL PROVIDE ALL LIGHTS, SIGNS, BARRICADES, FLAGMEN OR OTHER DEVICES NECESSARY FOR PUBLIC SAFETY DURING CONSTRUCTION.
- 3. ENCROACHMENT PERMIT SHALL BE OBTAINED FROM THE APPROPRIATE AGENCY PRIOR TO STARTING WORK.

EARTHWORK

- 2. COMPACTION SHALL CONFORM TO SECTION 3.9, "EARTHWORK" OF THE STANISLAUS COUNTY STANDARDS AND SPECIFICATIONS AND SECTION 19 OF THE STATE STANDARD SPECIFICATIONS. THE LOOSE THICKNESS OF EACH LAYER SHALL NOT EXCEED 8 INCHES.

AGGREGATE BASE:

1. THE AGGREGATE BASE MATERIAL SHALL CONFORM TO THE REQUIREMENTS OF SECTION 26. "AGGREGATE BASES" OF THE STATE STANDARD SPECIFICATIONS FOR CLASS 2, THREE-QUARTER (34) INCH MAXIMUM COMBINED GRADATION.

ASPHALT CONCRETE

- 1. THE ASPHALT CONCRETE SHALL CONFORM TO THE REQUIREMENTS OF SECTION 39. "ASPHALT CONCRETE" OF THE STATE STANDARD SPECIFICATIONS. ASPHALT CONCRETE SHALL BE TYPE "A". AGGREGATE USED IN ALL BUT THE FINAL COURSE AND SHALL BE THREE-QUARTER (3/2) INCH MAXIMUM MEDIUM GRADE. AGGREGATE USED IN THE FINAL COURSE SHALL BE ONE-HALF (1/2) INCH MAXIMUM MEDIUM GRADE.
- 2. THE ASPHALT SHALL BE GRADE PG 64-10 AS SPECIFIED IN THE STATE STANDARD SPECIFICATIONS, UNLESS OTHERWISE APPROVED BY THE ENGINEER.
- 3. PLACEMENT OF THE ASPHALT CONCRETE PAVING SHALL CONFORM TO THE REQUIREMENTS OF SECTION 3.12, "ASPHALT CONCRETE" OF THE STANISLAUS COUNTY STANDARDS AND SPECIFICATIONS AND SECTION 19 OF THE STATE STANDARD SPECIFICATIONS. LONGITUDINAL JOINTS SHALL CORRESPOND WITH TRAFFIC LANES. MINIMUM 2 LIFTS THROUGHOUT.
- 4. HEADER BOARDS SHALL BE INSTALLED TO PROTECT THE EDGES OF THE ASPHALT CONCRETE WHERE ROADS ARE PARTIALLY COMPLETED IN CONFORMANCE TO SECTION 3.15, "HEADER BOARDS" OF THE STANISLAUS COUNTY STANDARDS AND SPECIFICATIONS.

CONSTRUCTION AREA TRAFFIC CONTROL

- ACENCY

1. THE CONTRACTOR SHALL PROVIDE ALL LIGHTS, SIGNS, BARRICADES, FLAGMEN OR OTHER DEVICES NECESSARY TO PROVIDE FOR PUBLIC SAFETY IN CONFORMANCE WITH THE CURRENT ISSUE OF "MANUAL OF TRAFFIC CONTROLS WARNING SIGNS, LIGHTS AND DEVICES FOR USE IN PERFORMANCE OF WORK UPON HIGHWAYS" PUBLISHED BY THE STATE OF CALIFORNIA BUSINESS AND TRANSPORTATION

2. CONTRACTOR SHALL MAINTAIN ACCESS FOR LOCAL TRAFFIC AT ALL TIMES AND SHALL COMPLY WITH THE REQUIREMENTS OF CHAPTER 2, "SAFETY", STANISLAUS COUNTY STANDARDS AND SPECIFICATIONS

3. PRIOR TO START OF CONSTRUCTION, THE CONTRACTOR SHALL PROVIDE TO THE COUNTY FOR REVIEW AND APPROVAL, A CONSTRUCTION STAGING PLAN FOR WORK SHOWN ON THESE PLANS.

4. THE COST TO COMPLY WITH "CONSTRUCTION AREA TRAFFIC CONTROL" SHALL BE INCLUDED IN THE VARIOUS ITEM OF BID AND NO ADDITIONAL COMPENSATION WILL BE ALLOWED THEREFOR.


