FISCAL IMPACT:	
The Business and Professions Code provides for a Civil Limited Filing fee of \$300.00 of which the Administrative Office of the Courts currently return \$3.00 to the County for the Alternative Dispute Resolution Program. The amendment to the Contract will allow the \$3.00 to be increased to \$8.00. The Superior Court has projected that the increased revenue will generate an additional \$40,000 of estimated revenue each year for the Alternative Dispute Resolution Program. This is in addition to the current revenue of approximately \$80,000 received annually and will allow the Court to cover the current cost of the contract for Dispute Resolution Services, with Project Sentinel in the amount of \$100,000 and will allow them to consider increasing services provided.

Approval to Amend the Civil Limited Filing Fee Agreement with the Superior Court in Order to Receive Additional Revenue for the Court Alternative Dispute Resolution Program

DISCUSSION:

On November 22, 2005 the Board of Supervisors authorized the Superior Court of California, County of Stanislaus, in cooperation with the Stanislaus County Bar Association, Humphrey's College and California Rural Legal Assistance (CRLA) to create an Alternative Dispute Resolution (ADR) program utilizing a community based mediation process. The item had been submitted to the Board of Supervisors for approval at the request of the Superior Court because subdivision (a) of the Business and Professions Code section 470. provides that the Board of Supervisors may establish a fee to support dispute resolution programs. The Business and Professions Code section 470.3(a) allowed fees of up to \$320.00 to be charged for the filing of the first paper in an unlimited civil action and 470.3(b) allowed fees up to \$300.00 in a limited civil action.

On December 5, 2005 Stanislaus County and Stanislaus County Superior Courts entered into an agreement that followed Business and Professions Code section 470.3 authorizing revenue of \$8.00 for filing the first paper in unlimited civil, family law and probation actions and up to \$3.00 for filing the first paper in limited civil actions to be returned to the Court Alternative Dispute Resolution Program.

Assembly Bill 145 repealed section 470.3, added section 470.5, and restructured the way Dispute Resolution Program fees are established in order to simplify the civil filing fee by combining the varied surcharges and add-on fees into one filing fee, so that the same fees would be charged for the same service across all 58 Counties. Under section 470.5 of the Business and Professions Code, the Court may now receive revenue of eight dollars (\$8.00) on both unlimited civil action and limited civil actions. AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF STANISLAUS AND THE STANISLAUS COUNTY SUPERIOR COURT TO ESTABLISH THE STANISLAUS COUNTY COURT ALTERNATIVE DISPUTE RESOLUTION PROGRAM

THIS AMENDMENT to the Court Alternative Dispute Resolution Program is made and entered into on 3/4/05 by and between the County of Stanislaus, a political subdivision of the State of California (hereinafter referred to as "County"), and the Superior Court of California, County of Stanislaus (hereinafter referred to as the "Court").

RECITALS

WHEREAS, the parties previously entered into an agreement between the County of Stanislaus and the Stanislaus County Superior Court to establish the Stanislaus County Court Alternative Dispute Resolution Program on December 5, 2005 (the Agreement); and

WHEREAS, the parties now wish to amend that Agreement to modify certain of its terms as follows:

- 1. The County Board of Supervisors is authorized by the Business and Professions Code Section 470.5 to receive revenue of up to eight dollars (\$8.00) from the fee for filing the first paper in an unlimited civil, family law and probate actions and up to eight dollars (\$8.00) for filing the paper in limited civil actions seeking twenty five thousand dollars (\$25,000) or less, and to designate the additional revenue to fund an alternative dispute resolution program in accordance with Business and Professions Code section 465et seq.
- 2. All other terms and conditions shall remain the same.
