DISCUSSION:

The H-1B visa (U.S. Work Permit) is a non-immigrant INS classification used by non-citizens who will be employed in a specialty occupation. The U.S. Citizenship and Immigration Services requires employers to sponsor alien employees in their application of a U.S. Work Permit, including payment of an application filing fees of \$2,375. The U.S. Work Permit is non-transferable; it does not allow the employee to work for any other employer. Employees must be in a specialty occupation requiring at least a bachelor's degree to be eligible for sponsorship. Specialty occupations include engineering, physical sciences, law, medicine and health, among others. An employee may hold H-1B status for up to six years at a time. Should the employee choose to terminate the employer for the application filing fees. The employee is responsible for paying all legal fees associated with obtaining the U.S. work Permit.

There exists an extreme shortage of trained psychiatrists to meet the needs of individuals needing mental health and drug and alcohol services throughout the State. Although this shortage is much less dramatic in urban areas, it has reached crisis proportions in the majority of the State. Over the past years, Behavioral Health and Recovery Services has been losing ground in its ability to recruit and retain psychiatrists despite very aggressive recruitment efforts. These efforts have been pursued alone and in collaboration with private physicians in the community who are also looking to recruit individuals to expand their practices. Our competitors in this arena are not only county governments, but also the state and federal governments. Behavioral Health and Recovery Services currently has four vacant positions for psychiatrists.

Doina Vacalie, M.D. is Board Certified in Psychiatry with experience in working with clients with a serious and persistent mental illness. Dr. Vacalie's specialized training included four years of Psychiatry Residency training in addition to four years of medical school. Board Certification in the specialty of psychiatry exemplifies her excellence in the field. Her experience includes employment as a Locum Tenens psychiatrist with Stanislaus Behavioral Health Center from September 2001 to June 2002. During her tenure, Dr. Vacalie demonstrated that she has the qualifications and potential for what Behavioral Health and Recovery Services requires in an employee. Her familiarity with procedures and policy of the Behavioral Health Center will make her a good addition to the organization.

Bsed on the extensive background and experience brought to the position by Dr. Vacalie, and the difficulty and expense to fill the position, the Behavioral Health and Recovery Services recommends supporting Dr. Vacalie's application for an H-1B Visa.
