SUBJECT:

Approval to Accept the 2007-2008 State Youthful Offender Block Grant Funding for Juveniles Returning From Custody with the State of California; Establish Budget; and Add a Position

STAFF RECOMMENDATIONS:

1. Accept funding from the State of California to provide reentry and rehabilitative services to minors returning from Department of Juvenile Justice (DJJ) detention facilities and to those minors who might otherwise have been sent to DJJ facilities.
2. Authorize the Chief Probation Officer to sign and administer the Youthful Offender Block Grant (YOBG) funds from the State of California.

FISCAL IMPACT:

Stanislaus County has received \$278,735 for Fiscal Year 2007-2008 for the Youthful Offender Block Grant program. This funding is expected to reach \$1.2 million annually by Fiscal Year 2009-2010. This funding must be used for wards leaving State parole or those who would otherwise have been sent to the State Division of Juvenile Justice. The Probation Department is requesting that this revenue be placed in a Special Revenue fund, with the ability to re-budget the funding for use in subsequent years.

3. Authorize the Chief Probation Officer to enter into contracts with community-based organizations and professional service providers for the implementation of the plan.
4. Direct the Auditor-Controller to establish a new fund for the Probation Department as a separate legal budget unit and establish appropriations and estimated revenue of \$278,735 consistent with the attached budget journal.
5. Amend the Salary and Position Allocation Resolution to add one Deputy Probation Officer II to the Youthful Offender Block Grant Budget Unit.
6. Approve a resolution to accept and identify the signing authority for the funding.

DISCUSSION:

Effective September 1, 2007, Senate Bill 81 (SB 81) and its follow up legislation Assembly Bill 191 (AB 191), made major revisions to the Welfare & Institutions Code and implemented what has become known as the "Juvenile Justice Realignment Law."

The purpose of the legislation is to enhance the capacity of the Probation Department to implement an effective continuum of services to respond to crime and delinquency. It established the Youthful Offender Block Grant to provide resources for the custody and parole of youthful offenders to age 21. The State Department of Finance calculated the initial allocation at \$278,735 for 2007-2008, and it was received by the Treasurer's Office in November 2007. Funding in Fiscal Year 2008-2009 is estimated at \$900,000, and \$1.2 million in Fiscal Year 2009-2010. Funding is expected to remain at this level in future years.

Additionally, the law requires the Probation Department to develop a Juvenile Justice Development Plan outlining how the funding allocations will be used within specified categories. The initial plan calls for the addition of one Deputy Probation Officer II to provide re-entry planning, intensive supervision, and transitional services of wards already paroled and or being paroled out of DJJ facilities. The department will also need to contract for services for a wide range of alternative long-term placements for wards that would have previously been committed to DJJ.

The specifics of the Juvenile Justice Realignment Law are listed below:

Limit on wards that may be sent by counties to DJJ

Courts may now only commit to DJJ facilities those wards who committed offenses itemized in Welfare & Institutions Code section 707(b) or who committed a sex offense described in Penal Code Section 290(d)(3). The Probation Department must retain all "non-707(b)/non-290(d) (3) wards." Non-707(b) offenses include, but are not limited to, manslaughter, armed robbery, assault with a deadly weapon, armed burglary, battery with substantial bodily injury, grand theft, and arson. During 2007, there were no non-707 (b) wards committed to DJJ.

The Probation Department must now provide custody, placement, and community supervision to these wards including transitional housing, pre-employment services, drug rehabilitation and relapse programming, as well as other services to promote successful reentry into the community.

Return of wards to counties

SB 81 and AB 191 establish a recall process that the Chief Probation Officer may initiate, through the committing Court. If not recalled, all non-707 (b) offenders in DJJ facilities who are released to parole after enactment of SB 81 will be returned to the county of commitment for probation supervision. All non-707(b) offenders whose parole is suspended, cancelled or revoked, will also be returned to the custody of the Probation Department. These wards previously supervised in the community by State Parole Agents, will now have to be supervised by the Probation Department. Currently, there are no plans to recall already committed minors.

The Youthful Offender Block Grant (“YOBG”) Program

Under the YOBG program, the compensation amount is based on two factors: (1) The juvenile felony disposition rate as a percentage of the statewide total; (2) The County population aged 10-17 as a percentage of the statewide total.

SB 81 and AB 191 establish the expectation that YOBG funds will be utilized for specific services and associated costs for the YOBG program wards. The Probation Department is requesting the establishment of a Special Revenue Fund to ensure accurate tracking of revenue and expenses, to allow for revenue to be re-budgeted in subsequent fiscal years.

Program Implementation

The local custody and community monitoring of these additional wards will add to the already-strained juvenile services system and officer staffing levels in the Probation Department’s detention facility (juvenile hall) and field supervision units. The Corrections Standard Authority enforces state regulations that mandate a minimum staffing ratio of one direct supervision staff person to every ten detainees as well as regulations regarding the overcrowding of those facilities. Even with early release programs in place, the 158 bed juvenile hall remains overcrowded. Without a commitment facility to help manage these additional wards, it will be necessary for the Probation Department to contract with other agencies for long-term commitment and rehabilitative services. Upon release from programs there will also be the increased need to closely supervise these wards in the community and provide for re-entry services.

The Probation Department is developing the program described below to focus on reducing recidivism while providing support and services to assist these wards in becoming successful citizens.

The Probation program will include four phases:

1. Due to a lack of local bed space, the first phase will require the department to enter into contract services with public and private long-term rehabilitative programs designed to serve the more serious offender that would have previously been committed to DJJ. These contractors will provide services including custodial, education, substance abuse, behavior modification programs, life skills development, mental health, vocational counseling, as well as sex offender management programs. A Probation Officer will monitor offenders closely by visiting the ward monthly to ensure the case plan is being followed and that rehabilitative progress is being made.
2. Prior to release from custody, the Probation Officer will prepare a re-entry plan. An assessment will be conducted to determine the risk presented to the community and a multi-agency Resource Review Board will address their specific needs. A case plan will be developed with specific goals prior to their transition into the community.
3. Transitioning from placement back into the community based on the case plan is an essential component to a ward's ultimate success. This includes providing intensive supervision, relapse prevention, counseling and vocational services. Mental and physical health services will also be provided in this phase. For older young adults this may include funding transitional housing and sober housing living environments as well as short term relapse beds in an appropriate facility.
4. The fourth phase is the aftercare phase, which will assist the transition from provider-supported services to being independent productive citizens in the community. Focus on obtaining and maintaining employment, paying restitution, and ultimately successfully completing their probation are primary goals.


WHEREAS, the law requires the Probation Department to develop a Juvenile Justice Development Plan outlining how the funding allocations will be used within specified categories.

I. Program Name or Service Description: Youthful Offender Reintegration, Rehabilitation, and Vocational Education Program

Category for this Program/Service: A – Implementing a Risk and Needs Assessment; E – Reentry and Aftercare.

Describe the county programs, placements, services, or strategies to be funded by the block grant allocation pursuant to WIC Section 1961 including, but not limited to the programs, tools and strategies outlined in WIC Section 1960. (1-5 pages):

Under SB 81 and follow-up legislation AB 191, a Parole Placement plan must be developed prior to a youth paroling from a DJJ facility. The Probation Department will work collaboratively with DJJ Parole in developing the case plan in an effort to provide for a smooth transition of services once the youth is under the jurisdiction of the Probation Department. State Parole will retain jurisdiction of the ward for the first fifteen days after being released to allow for the Probation Department to arrange a hearing in Juvenile Court to transfer jurisdiction back to the County.

Upon the transfer of jurisdiction back to the County, the Probation Department will utilize a multi-agency screening committee (Resource Review Board) and a validated risk and needs assessment program to develop a re-entry plan and supervision plan. The Resource Review Board will consist of representatives from the Probation Department, Juvenile Justice Mental Health, Health Services Agency, and the Stanislaus County Office of Education. The committee will review the minor's needs and determine the appropriate course of action and available resources to assist in meeting those needs. Resulting action plans will provide the returning minors with services that will include transitional housing, medical treatment, long-term placement, vocational training and job placement, education services, and substance abuse, sex offender and mental health treatment. The validated risk and needs assessment utilized by the Probation Department is the Back on Track program. The Probation Department currently has a contract with the program's provider, Assessments.com. While there are no expenses currently anticipated for the implementation of the Resource Review Board, it is the intention of the Probation Department to allocate YOBG funds toward the continued implementation of the Back on Track assessment program.

Funding will be allocated for emergency medical and mental health services and transitional housing for minors returning from DJJ commitments and for minors who may have otherwise been committed to the DJJ. Funding will also provide for wrap-around services including contracts with, though not limited to, the providers of

mental health, substance abuse, and sex offender treatment. Reentry and aftercare programs meet Stanislaus County's Comprehensive Multi-agency Juvenile Justice Plan by providing offenders with treatment, educational services, and housing.

Funding will also be allocated to provide for reimbursement of costs associated with providing vocational education programs to minors returning from DJJ commitments and to other minors who may have otherwise been committed to the DJJ. One such program is Project Success, which is operated by the Stanislaus County Office of Education. The program is designed to prepare youth on how to gain meaningful employment and/or how to access educational and training opportunities. The program helps to prepare youth to become competitive job seekers in the changing job market by teaching youth how to search for employment, how to interview, and how to set and achieve goals. Real life job training is taught with Habitat for Humanity employees and volunteers, followed by job placement.

- **Board and Care Facilities:** Various board and care homes are located throughout Stanislaus County and will be sought for appropriate placement on adult returnees as the need arises.

It is recommended that the Probation Department be given the flexibility to enter into contracts with reentry, aftercare, transitional housing, and vocational programs that the department deems to meet the Multi-agency Juvenile Justice Plan - \$80,000. YOBG Year 1 funds will also be used specifically for six months of contracted assessment services - \$1,500. Total allocation - \$81,500.

II. Program Name or Service Description: Intensive Probation Supervision Programs

Category for this Program/Service: D – Probation Supervision Programs.

Describe the county programs, placements, services, or strategies to be funded by the block grant allocation pursuant to WIC Section 1961 including, but not limited to, the programs, tools, and strategies outlined in WIC Section 1960. (1-5 pages)

The Juvenile Justice Crime Prevention Act funds the Probation Department's High Risk Offender (HRO) Program. The objective of the program is to reduce juvenile crime and gang involvement in the target population and to increase offender accountability. Specific program goals include the following: decrease arrests; increase successful completion of probation; decrease new law violations; decrease violations of probation; increase payment of restitution; decrease the number of days incarcerated; clear 100 juvenile bench warrants by either arrest or motion. In order to achieve these goals, the community-based program provides the following evidence-based practices to high-risk juvenile probationers: frequent home visits from deputy probation officers, including during weekend and evening hours; multi-agency probation searches; Aggression Replacement Training (ART); Accountability Changes Teens (ACT); and referrals to community agencies relative to the needs identified during a validated risk/needs assessment.

The Probation Department will utilize YOBG funding for an additional officer to provide High Risk Offender supervision to minors returning from DJJ commitments and to minors whom would have otherwise been committed to the DJJ. Funding will also provide for necessary training and equipment. The officer will be assigned to an intensive supervision unit and will utilize a validated risk and needs assessment program to assist in the development of a reentry and supervision plan. The returnees will receive the same level of supervision and evidence-based practices provided to other offenders identified as high risk.

YOBG Year 1 funds will be used specifically for the salary, benefits, and armed officer training of the senior probation officer for a six-month period (January through June) - \$48,000; required safety equipment (firearm, body armor, tactical vest, baton, holster, equipment belts, chemical defense agent, and holders) - \$3,000; computer and printer - \$1,735; cellular phone - \$100; vehicle - \$27,000; vehicle safety and identification equipment - \$5,000; vehicle computer, installation, and internet - \$6,400; armed academy training - \$2,000. Total allocation - \$93,235.

III. Program Name or Service Description: Placement Opportunities Program

Category for this Program/Service: B - Placements

The Stanislaus County Probation Department is the largest Probation Department in the State without a commitment facility. The long-term goal, as recommended by the Stanislaus County Multi-agency Juvenile Justice Master Plan, is to build a commitment facility in Stanislaus County. Preparation for this facility has already been implemented with the goal that the Probation Department will be able to house

and treat these offenders locally. Until then, it is anticipated that a portion of the offenders returning to the jurisdiction of the County, in addition to those minors whom would have been otherwise committed to DDJ, will be in need of placement in commitment facilities. The Fouts Springs Youth Facility, Rite of Passage, and Glenn Mills Schools have been identified as such potential commitment programs. These programs meet the department's goals in that they supports offender accountability and community safety and provide offenders with treatment, vocational, and educational services.

It is recommended that the Probation Department be given the flexibility to enter into contracts with those placement and commitment facilities that the department deems to meet the Multi-agency Juvenile Justice Plan.

YOBG Year 1 funds will be used specifically for contracts with the identified commitment programs - \$96,000; salary and travel expenses for probation officers to visit commitment programs - \$5000; and travel and training expenses for two officers to attend placement core training - \$3,000. Total allocation - \$104,000.

Section 3c – JUVENILE JUSTICE DEVELOPMENT PLAN JJCPA COORDINATION

Describe how the new program funded by the Youthful Offender Block Grant Program coordinates with programs identified in the County's Juvenile Justice Crime Prevention Act – Comprehensive Multi-agency Juvenile Justice Plan (Chapter 353 of the Statutes of 2000) (A.B. 1913). (1-3 pages)

As a result of the Crime Prevention Act of 2000 (the Juvenile Justice Crime Prevention Act), the Stanislaus County Probation Department was able to implement four programs to fill the gaps in the juvenile continuum of services.

The High Risk Offender Project provides intensive supervision services to those minors assessed as being high risk to community safety and the highest risk to re-offend. In collaboration with local law enforcement and service providers, the program intends to decrease arrests, increase successful completion of probation, decrease new law violations and violations of probation, increase payment of restitution, decrease the number of juvenile hall days, and clear bench warrants by arrests or motion. Interventions include frequent home visits from deputy probation officers, multi-agency probation searches, Aggression Replacement Training (ART), Accountability Changes Teens (ACT), and referrals to community agencies for counseling relative to their specific needs. One of the contracted service providers is the Center for Human Services (CHS), which facilitates ACT and ART programs. CHS program activities include educational and life skills groups, one-on-one sessions, school and home visits, school progress and behavioral monitoring, parent education and support, resource and referral, linkage with Probation Officers, and work readiness training. The goal of A.C.T. is to positively impact youthful clients by enrolling in school and improving school attendance and behavior, improving self-functioning skills, decreasing use of substances, and decreasing the number of days in Juvenile Hall.

The Juvenile Drug Court Program provides long-term treatment and accountability to youthful offenders. Program goals include the reduction of drug use, an increase in the successful completion of probation, a decrease in new law violations, a decrease in violations of probation, an increase in the payment of restitution, and a decrease in the number of juvenile hall days. Interventions include home visits from deputy probation officers, probation searches, intensive individual and group counseling, and in-patient treatment.

The Home Supervision Program helps to avoid juvenile hall overcrowding by providing community supervision to minors either pending Court or sentenced to a period of supervision. Program goals include the following: decrease arrests, increase successful completion of probation, decrease new law violations, decrease violations of probation, increase payment of restitution, decrease the number of juvenile hall days, and increase attendance in scheduled Court hearings. Interventions include frequent contact with and home visits from probation corrections officers and, in some cases, electronic monitoring.

The Youthful Offender Block Grant (YOBG) funds will enhance the capacity of the Stanislaus County Probation Department in providing appropriate rehabilitative and supervision services to youthful offenders in the Juvenile Justice Continuum. The new programs and services funded through YOBG will coordinate with the programs identified in the County's Juvenile Justice Crime Prevention Act – Comprehensive Multi-agency Juvenile Justice Plan.

The Stanislaus County Probation Department recognizes that in order to develop an appropriate supervision and treatment plan for the juvenile population we serve through our continuum of services, it is necessary to utilize a validated risk and need assessment tool. As previously noted, the Probation Department has implemented a validated risk and needs assessments tool for juvenile offenders. The tool will continue to be used for every youth under our jurisdiction (including those programs funded through JJCPA) and will aid in identifying appropriate dispositions, treatment referrals to evidence based programs, and developing reentry plans for those youth returning to County jurisdiction from the Division of Juvenile Justice, as well as those returning home on probation after detention in Juvenile Hall, the Camp, or out-of-home placement.

As a result of no longer being able to send non-707(b) WIC juveniles to the Division of Juvenile Justice, and due to the unmet need of a local commitment facility, the Stanislaus County Probation Department anticipates there will be an increase in juvenile offenders in need of commitment programs. Therefore, appropriate programs will continue to be sought and utilized for offender accountability, rehabilitation, education, and treatment.

The Probation Department and Resource Review Board will continue to utilize a validated risk and needs assessment to develop individualized case plans for all youth detained in Juvenile Hall, regardless of their length of stay. Additionally, YOBG funds will be used to provide evidence-based programs to the youth detained in Juvenile Hall. Probation staff will also be trained in various evidence based programs that they will directly deliver to the youth. Currently, probation correctional officers are conducting the evidence-based program "Aggression Replacement Training (ART)" in Juvenile Hall. In addition, we will look for opportunities to further train our staff to deliver an enhanced level of programs to youth under our jurisdiction.

The Youthful Offender Reintegration, Rehabilitation, and Vocational Education Program, the Intensive Supervision Program, and the Placement Opportunities Program will offer intensive probation supervision programs that focus on developing individualized case plans for reentry from DJJ, out-of-home placement, and specialized supervision services. Currently, the Probation Department does not provide intensive supervision services to youth returning from placement. We will use YOBG funds, along with a proposed reorganization, to provide intensive supervision services in an effort to make their transition back into the community more successful. Each of the programs will make available transitional housing and vocational education to assist in their reintegration back into society, something that has never previously been offered by the Probation Department.
