### **DISCUSSION:**

The United Community Center Advisory Board representing the community and the United Community Center and Park approached the Department of Parks and Recreation (Department) last year regarding the need for assistance in completing a grant application to install two (2) horseshoe pits at the facility. The grant has been awarded and this new park amenity will support the preservation of the sport of horseshoeing through instruction, games and tournaments. The United Community Center and Park is located at 8900 Laird Street in the unincorporated town of Grayson.

Through its Building Strong Neighborhood Impact Council Mini Grant Program, the United Way of Stanislaus County offers small grants, up to \$500, to develop and sustain strong healthy neighborhoods. The mission of the grant program is to assist neighborhoods' and resident's capacities to develop and sustain healthy neighborhoods.

The United Community Center Advisory Board was the organization that applied for the grant. The application came from the group with input from the Department as to how to organize and request the funding. On January 24, 2008, the United Community Center Advisory Board and the Department of Parks and Recreation were notified by the United Way that the grant application had been awarded funding (Exhibit A).

This project benefits the community by providing an additional recreational amenity that allows families from the local neighborhoods to interact and exchange life experiences while having fun. This grant-funded recreational opportunity will bring together residents from Grayson, Westley and Vernalis with the goal of completing a neighborhood project while continuing to promote community pride and partnerships through the United Community Center and Park.

The United Community Center and Park is a County facility and as such, the Department of Parks and Recreation and its staff will be present to oversee the entire project. Community volunteers will assist with preparing the grounds and building the backstops under direction by County staff. There will also be a group of residents providing light refreshments during the installation process. The horseshoe pits are planned to be located at the east end of the park (Exhibit B).

The installation of the two (2) horseshoe pits is scheduled for completion during the project performance period of February 1, 2008 and no later than June 30, 2008.


