Approval to Accept an Anonymous Donation for the Purchase of a Patrol Vehicle and Associated Equipment for the Sheriff's Department K-9 Unit

DISCUSSION:

The Stanislaus County Sheriff's K-9 Association received a donation in the amount of \$37,000 for the purchase of a patrol vehicle and associated equipment consisting of standard patrol vehicle equipment (emergency lights, computer, radios, scanner, etc.), signage, window tinting, a K-9 insert kit and heat alarm sensor with electronic door opening unit to be used by the Sheriff's Department K-9 Unit.

This generous donation will allow the Sheriff's Department to increase the current fleet of 7 K-9 patrol vehicles to 8 in the Sheriff's K-9 Unit. It will provide the Sheriff's Department with the availability of an additional vehicle to deploy for specialized operations and use when a patrol vehicle is out of service or is at General Services Agency's Fleet Services for maintenance.

The special attributes and training of a Deputy Sheriff and his/her canine partner are most effective when their services are immediately available to the community. Acceptance of this generous donation will provide the Sheriff's Department with the use of an additional outfitted K-9 patrol vehicle which will enhance public safety and public relations throughout Stanislaus County.
