Attached please find a request from the SOCIETY OF HANDICAPPED CHILDREN & ADULTS (GROUP) requesting the use of Modesto Reservoir and its Water Ski Course on the following Saturdays including June 21st, July 19th, August 9th and September 6th, 2008 from 8:00 a.m. until 4:00 p.m.

The Department does not have any objections to this request and recommends the Board to approve the request as follows:

- By Tuesday, June 17, 2008, no later than 3:00 p.m., require the Society of Handicapped Children & Adults to provide the Department of Parks and Recreation. Attention Margarita D. Ramos, Deputy Director, its Certificate of Insurance with a minimum general liability of \$1 million and the Endorsement naming Stanislaus County as an additional insured.
- By Tuesday, June 17, 2008, no later than 3:00 p.m., require the Society of Handicapped Children & Adults to provide to the County any additional volunteer organizations/groups their Certificate of Insurance with a minimum general liability of \$1 million and their Endorsement naming Stanislaus County as an additional insured.
- By Saturday, June 21, 2008, upon entrance to the facility, require the Hold Harmless Agreement (Organization) and Hold Harmless Agreements (Individual) to have been completed and given to the on-site coordinator Tom Dias, Manager of Modesto Reservoir or his designee.
- A volunteer organization/group that has not completed a Hold Harmless Agreement (Organization) and all Insurance requirements prior to an event date must do so no less then forty-eight (48) hours prior to the event date.
- An individual who has not yet participated must complete a Hold Harmless Agreement (individual) and give to the on-site coordinator upon entering the facility on an event date.

- The expected number of persons per event date is 20 youth and 40 adults.
- Vehicle and Vessel entries are payable upon entrance.
- There is an Exclusive Use Fee of \$90 per event date.
- There is an Administrative/Reservation Fee of \$10 for this request.
- The use of Department issued portable restrooms for these event dates is \$50 per unit. If the GROUP brings in portable restrooms, they shall be placed in areas as directed by your on-site contact person.
- The total fee for the GROUP events is \$570 including portable restrooms. By Tuesday, June 17, 2008, no later than 3:00 p.m. require the Society for Handicapped Children & Adults to provide the Department of Parks and Recreation payment for their GROUP Exclusive Use request.
- No alcohol is to be sold or served during the GROUP event.
- The area is to be left in a clean condition.
- Upon arrival to the facility, Mr. Tom Dias, Manager or his designee will serve as your on-site contact person. He can be reached at tdias@parksrec.org or by phone at 209.874.2893
