WHEREAS, Jim & Gladys Halvorson are both active volunteers for Gateway Community Church in Denair: Gladys serves as a Greeter before the church services, and as 'Hostess' between church services (refreshments, etc.). Jim serves as a Sunday School teacher, a Church Board member, and for over five years was the 'chef' for the church's weekly meal that was prepared and provided to the homeless and those in need, with Gladys at his side, helping him.
