AN ORDINANCE RELATING TO MEMBERSHIP OF THE STANISLAUS COUNTY SAFETY BOARD

THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS, STATE OF CALIFORNIA, ORDAINS AS FOLLOWS:

Section 1. Section 2.36.020 of the Stanislaus County Code is amended to read as follows:

"The Safety Board shall have twelve members. One member shall be a member of the Board of Supervisors appointed by the board. Nine members shall be the heads of the following departments: Sheriff-Coroner, Health Services Agency, Behavioral Health and Recovery Services, Community Services Agency, Public Works, Chief Executive Office, Office of Emergency Services, Environmental Resources and Parks, and the General Services Agency. One member shall be a department head appointed by the Chief Executive Officer from among the various other departments not already mentioned and to serve for a period of one year. The County Counsel, or his representative, shall also be a member of the board. The Secretary of the Safety Board shall be the Safety Officer, or other person designated by the Chief Executive Officer, who shall also coordinate the day-to-day activities and functions of the County Safety Program. The Safety Officer shall be a nonvoting member. The Safety Board shall elect a chairperson from among its own members who shall serve for one year or until a successor is elected."

Section 2. This ordinance shall take effect thirty (30) days from and after the date of its passage and before the expiration of fifteen (15) days after its passage it shall be published once, with the names of the members voting for and against the same, in the Modesto Bee, a newspaper published in the County of Stanislaus, State of California.
