Approval of Fiscal Year 2008-2009 Renewal Agreements for Contracted Program Services for Individuals and Families Receiving Temporary Aid to Needy Families, Child Welfare, and Adult Services – Community Services Agency Page 2

DISCUSSION:

The Community Services Agency (CSA) relies on many partner agencies to provide services to individuals and families receiving Child Welfare Services through the Families in Partnership (FIP) program and Adult Protective Services. In support of Child Welfare Services these agencies provide a wide range of services designed to: provide legal assistance, improve family functioning which will enable children to remain in or return safely to their home or the home of a guardian; provide domestic violence prevention/case management and counseling services. In support of Adult Protective Services one agency provides legal assistance.

CSA requests Board of Supervisors approval to renew contracts with the 6 vendors listed on Attachment 1. Some of the Expected Outcomes include:

- On average 222 children will remain safely in their homes or the homes of responsible guardians and avoid foster care.
- Approximately 180 frail adults will remain safely in their homes and avoid institutionalized care.

As required by the Board of Supervisors on January 24, 2006, Attachment 1 includes those agreements that have a cumulative value that exceeds \$100,000 for the period beginning July 1, 2003. CSA will identify any amendments to these agreements in future quarterly reports to the Board of Supervisors. CSA has listed a separate column, titled "Proposed Contract Amount and Period", that indicates the contracts that are to be approved with this Board agenda item. Several multi-year contracts with these vendors were approved previously by the Board but exceed the \$100,000 threshold and must be included in this report. The total amount of the contacts to be renewed through this Agenda item is \$806,275.

POLICY ISSUE:

Approval of the agreements listed on Attachment 1 supports the Board's priority of a healthy community and enables Community Services Agency to provide services that promote self-sufficiency, family preservation and support through effective partnerships with community based organizations.

STAFFING IMPACT:

There is no staffing impact associated with this request.
