Approval to Increase the Amount of the Contract with the Law Firm Meyers Nave for Legal Services Related to the Crows Landing Air Facility Development Project

## **DISCUSSION:**

On July 6, 2007, the County entered into a Legal Services Agreement with the law firm Meyers, Nave, Riback, Silver and Wilson ("Meyers Nave") to assist the County in negotiation of a Disposition and Development Agreement with PCCP West Park, LLC ("West Park"), the candidate for master developer of the Crows Landing Air Facility. Pursuant to the Crows Landing Air Facility Pre-Development Agreement, West Park agreed to reimburse the County for the cost of its consultants, including the costs for the assistance of Meyers Nave.

The initial contract amount was estimated to be \$100,000. The cost for Meyers Nave reached \$90,624 for the period July 1, 2008 through December 31, 2007. At the 2007-2008 Mid-Year Budget Report, your Board approved an increased contract amount of \$125,000 for the period January 1, 2008 through June 30, 2008. Additional legal services were required to finalize the essential terms of the Disposition Development Agreement that was part of the project description approved by the Board on April 22, 2008. The additional work requires the Office of County Counsel to increase the authorized amount of the contract with Meyers Nave by \$75,000, resulting in a new total of \$200,000 for the period January 1, 2008 through June 30, 2008. With the requested increase in the contract amount, the new total, cumulative contract amount for Fiscal Year 2007-2008 would be \$290,624.

Staff recommends that the Board of Supervisors approve and authorize an increase of \$75,000 in the Meyers Nave contract amount for the 2007-2008 Fiscal Year.
