Approval to Adopt Plans and Specifications for Federal Project No. STPL-5938(151) Titled "RSTP Road Resurfacing Program A (FY 2007/2008 – Phase I)" which is Part of the Federal Regional Surface Transportation Program and Set the Bid Opening Date and Time for August 20, 2008, 2:30 P.M.

4. Direct the Public Works Department staff to mail the notice inviting bids to trade journals as required by law.

DISCUSSION:

The RSTP Road Resurfacing Program A (FY 2007/2008 - Phase I) will consist of placing asphalt-concrete overlay onto 34.78 miles of road surfaces creating a smooth, durable, water resistant pavement surface. New striping will be applied on the center line and edge lines as well as various pavement markings. Shoulder backing will be placed to stabilize the shoulders.

All preliminary engineering was done in-house by County staff.

The following roads are included in the program:

- 1) Claus Road from Claribel to Burlington Northern Santa Fe Railroad Crossing
- 2) Claribel Road from Litt Road to Albers Road
- 3) Tully Road from Pelandale Avenue to Ladd Road
- 4) Carver Road from Highway 219 to Bangs Avenue
- 5) Dale Road from Highway 219 to Ladd Road
- 6) Main Street from Monte Vista Avenue to Gratton Road
- 7) Fulkerth Road from Faith Home Road to N. Washington Road
- 8) Hickman Road from Keyes Road to Monte Vista Avenue
- 9) Gratton Road from Main Street to Keyes Road
- 10) Montpelier Road from 2 miles North of Keyes Road to Merced County; Including Keyes Road from 150 feet West of Montpelier Road to 150 feet East of Montpelier Road
- 11) Valley Home Road from State Route 120 to 2 miles South of San Joaquin County
- 12) Rodden Road from Cimarron Trail to Orange Blossom Road
- 13) Orange Blossom Road from the Stanislaus River to Horseshoe Road
- 14) 26 Mile Road from Dodds Road to Sonora Road
- 15) Monte Vista Avenue from Hickman Road to 2 miles East of Hickman Road

This project is exempt from the California Environmental Quality Act, Class 1, California Code of Regulations, Title 14, #15301 (Existing Facilities). A Notice of Exemption was filed with the County Clerk on April 21, 2008.

NEPA clearance was given on May 30, 2008. The project is exempt in accordance with 23 CFR 771.117 under 23 DFR 771 activity (d)(1). An archaeological review as performed by Tremaine & Associates, Inc. for the County.

The project is anticipated to begin construction on September 29, 2008 and end November 10, 2008.
