DISCUSSION:

In Fiscal Year 2006-2007, the State appropriated funding statewide to expand and enhance current Substance Abuse and Crime Prevention Act programming, more commonly known as Proposition 36. The funding is provided through the Substance Abuse Offender Treatment Program. The goal of the funding is to improve Proposition 36 offender accountability; increase participation, retention and completion rates; and expand treatment services.

Funding for this program has continued over the last two fiscal years, unfortunately at reduced amounts. On an annual basis, counties are asked to submit a plan for continued funding at the amounts established through the State Budget. Stanislaus County has tentatively been allocated \$248,719, pending approval of a final State Budget. In addition, a commitment of local funds at a ratio of one dollar for every nine State dollars is required. This amount was included and approved in the Department's 2008-2009 Proposed Budget submission. The criteria for continued funding through this program includes the following:

- The establishment and maintenance of a dedicated Court calendar with regularly scheduled reviews of treatment progress for persons ordered to drug treatment;
- The establishment of a Drug Court, and a willingness to accept defendants who are likely to be committed to state prison;
- The establishment and maintenance of protocols for the use of drug testing to monitor offenders' progress in treatment; and
- The establishment and maintenance of protocols for assessing offenders' treatment needs and the placement of offenders at the appropriate level of treatment.

The current program, which is a collaboration between Behavioral Health and Recovery Services, the Probation Department, and Superior Court meets all of the required criteria to maintain this funding stream.

A portion of the funding is used to enhance efforts to engage offenders by having a Deputy Probation Officer and a Behavioral Health Specialist make direct contact with offenders following sentencing and providing immediate assessments, as appropriate. Currently, for ease of access, the Proposition 36 and Offender Treatment Program offices are located in the Adult Probation Department building across the street from the Courthouse. Without this additional funding, it is estimated that 50% of offenders sentenced to the Proposition 36 Program will not appear at the office to schedule an initial appointment. The additional staffing also helps to ensure that offenders keep the appointment once it has been scheduled, avoiding a violation of probation and a required court appearance.

The balance of the funding will be used, as is available, to enhance treatment options, including expanded residential treatment services, use of the Co-Occurring Disorder Treatment Program at Stanislaus Recovery Center for those offenders diagnosed with co-occurring substance abuse and mental health disorders, enhanced after care services and random substance abuse testing.

The Department is requesting authorization to submit the annual plan and accept funding on an ongoing basis. Future years' allocations will be included in the Department's budget, along with the required County Match funds. Any changes to the budgeted amounts will be returned to the Board for approval.

POLICY ISSUE:

Approval to submit an Annual Plan to the State for Substance Abuse Offender Treatment Program Funds and accept subsequent funding will support the Board priorities of *A safe community, A healthy community and Effective partnerships* and will enable additional services to be provided to local residents.

STAFFING IMPACT:
