Approval for Memorial Medical Center to Have Exclusive Use of Laird Park's Group Picnic Area and Shade Structure On September 20, 2008, for their Cancer Awareness Run & Ride Page 2

DISCUSSION:

A request from Memorial Medical Center's Community Outreach Division has been received for use of Laird Park's Group Picnic Area and Shade Structure to be used as a rest stop for their Cancer Awareness Run & Ride being held on Saturday, September 20, 2008. This is a first time request from Memorial Medical Center for use of Laird Park.

Understanding that cancer is the second leading cause of death in the Untied States; and while millions of people are living with cancer or have cancer, Memorial Medical Center has developed "The Cancer Awareness Run & Ride" to increase public awareness regarding cancer awareness, cancer prevention, and early detection, as well as nutrition, exercise and living a healthier life.

The event will be held at the Modesto Junior College West Campus with exhibits available from 7:00 a.m. to 1:00 p.m. The Run includes a 10k and 2-mile run/walk route while the Ride includes a 63-mile, 30-mile, and 12-mile route. It is the 30-mile and 63-mile run routes that will use Laird Park as a rest stop.

The Department of Parks and Recreation does not have any objections to this request for exclusive use and as such necessitates Memorial Medical Center to adhere to the following requirements:

- On or by Wednesday, September 17, 2008, no later than 3:00 p.m., require Memorial Medical Center, to provide the Department of Parks and Recreation a Certificate of Insurance with a minimum general liability of \$1 million and endorsement naming Stanislaus County as an additional insured.
- A Hold Harmless Agreement (Organization) is required. The original agreement must be completed and returned on or by Wednesday, September 17, 2008, no later than 3:00 p.m.
- The expected number of participants for the use of Laird Park as participants is 150.
- The expected number of spectators at Laird Park is 75.
- No alcohol shall be sold, served, or consumed during this exclusive use.
- The Group shall supply one unisex restroom for their event that will be placed near the Group Picnic Area and Shade Structure.
- The Group shall work with all other necessary groups, organizations, or other governmental personnel as required by the Department to ensure a safe event.
- Please remit payment in the amount of \$100 for the reservation and use on or by Wednesday, September 17, 2008, no later than 3:00 p.m.
