DISCUSSION:

On January 24, 2006, the Board of Supervisors adopted policies for the approval and reporting of contracts and agreements. Policy #3 requires the Purchasing Agent to, "at least annually. . .prepare a report to the Board of Supervisors of all contractual services (except Personal Service Contracts) provided by vendors/contractors for more than one County Department during the fiscal year where the total exceeds \$50,000."

General Services Agency - Purchasing focused on payments to vendors across all departments where total cumulative payments across multiple departments exceeded \$50,000. Vendors that receive payments from only one department in a single fiscal year in excess of \$100,000 are not covered in this report as these items require Board of Supervisor approval.

In preparing this report, which covers July 2003 through June 2007, the Oracle Purchasing Module proved to have limitations. Department Heads have reviewed this report and adjusted for vendors that had previously been reported to the Board of Supervisors.

The resulting report contains vendors not previously reported to the Board of Supervisors, where the payments cross more 'than one department and were greater than \$50,000 in any fiscal year from July 1, 2003 through June 30, 2007."

This report fulfills the Purchasing Agent's requirement to report annually all contractual services, except Personal Service Contracts, provided by vendors/contractors for more than one County Department during the fiscal year where the total exceeds \$50,000, set by Board Resolution 06-0058.

POLICY ISSUES:

Approval of award of this agreement supports the Board's priority of efficient delivery of public services.

There is no staffing impact associated with this request.
