Approval for Escalon High School to Have Exclusive Use of Woodward Reservoir on Wednesday, October 8, 2008, for their 15th Annual Escalon Invitational Cross Country and Waiver of Fees for the Exclusive Use Page 2

DISCUSSION:

A request from Escalon High School has been received to use Woodward Reservoir for its 15th Annual Escalon Invitational Cross Country. The Escalon Invitational is a small cross-country meet providing an additional opportunity for small schools to compete in a safe outdoor recreational environment. The meet usually draws approximately 200 high school students who compete in seven different race divisions. This is a long-time request from Escalon High School and its Cross Country Team.

The Department of Parks and Recreation has partnered with Escalon High School for the past fifteen (15) years and continues to support cross-country as a special interest outdoor recreational opportunity that exists when using County facilities. The event is held in the undeveloped areas of the reservoir and does not interfere with day-to-day operations.

The Department of Parks and Recreation does not have any objections to this request for exclusive use and as such necessitates Escalon High School to adhere to the following requirements:

- By Tuesday, October 7, 2008, no later than 3:00 p.m., require Escalon High School, to provide the Department of Parks and Recreation a Certificate of Insurance with a minimum general liability of \$1 million and endorsement naming Stanislaus County as an additional insured.
- A Hold Harmless Agreement (Organization) is required. The agreement must be completed and returned by each school's coach on the event date at Woodward Reservoir to be held on Wednesday, October 8, 2008, no later than upon entrance.
- By Tuesday, October 7, 2008, no later than 3:00 p.m., require Escalon High School Cross Country coach provides a pass list with names of schools and number of buses and/or vehicles needing to be waived.
- Require coaches and team members to check in with Entrance Station staff.
- The expected number of participants for this event is 200 youth and 30 coaches.
- The expected number of spectators for this event is 100 persons.
- No alcohol shall be sold, served, or consumed during this exclusive use.
- Upon request the Department will provide additional trash receptacles.
- By event start time have identified the running route(s) and provide such information to designated Woodward Reservoir staff.

DISCUSSION (Continued):

• Escalon High School Cross Country staff shall work with all other necessary groups, organizations, or other governmental personnel as required by the school district to ensure a safe environment.
