- 3. Authorize the Behavioral Health Director, or her designee, to negotiate and sign amendments to all agreements included in this agenda item, to add services and payment for services up to \$50,000 per agreement, budget permitting, throughout calendar year 2009.

FISCAL IMPACT:

Behavioral Health and Recovery Services approved budget for Fiscal Year 2008-2009 contains funding in the amount of \$153,560 which is available for the renewal agreements listed in Attachment A of this agenda item. Budget adjustments will be made during the Fiscal Year 2008-2009 as necessary, based on actual contract activity. These renewal agreements have calendar year terms, funding for the first six months of Fiscal Year 2009-2010 will be included in the proposed budget for Fiscal Year 2009-2010. All agreements include a 14-day or 30-day notice of termination or reduction-in-funding clause. There is no impact to the County General Fund.

Approval of Renewal Agreements with Various Providers for the Provision of Mental Health and Ancillary Services – Behavioral Health and Recovery Services Page 2

DISCUSSION:

Behavioral Health and Recovery Services contracts with numerous individuals and agencies to provide behavioral health services to Stanislaus County residents. Agreements are renewed based on the demonstrated ability to deliver required outcomes effectively along with availability of funding.

Agreement Renewals:

As required by the Board of Supervisors on January 24, 2006, Attachment A includes those agreements that have a cumulative value that exceeds \$100,000, for the period beginning July 1, 2003 (Fiscal Years 2003-2004, 2004-2005, 2005-2006, 2006-2007, 2007-2008, and 2008-2009). Any amendments to these agreements will be identified in subsequent quarterly reports to the Board of Supervisors.

Behavioral Health and Recovery Services experiences occasional funding opportunities and unanticipated increases in the utilization of services throughout the year. On many occasions, this additional funding is time sensitive; hence, the organization requests authorization for the Behavioral Health Director, or her designee, to negotiate and execute amendments up to \$50,000 to the agreements listed in Attachment A and B of this agenda item, when necessary and without further Board of Supervisor action throughout calendar year 2009.

It is essential that agreements be in place by January 1, 2009 to avoid disruption of critical services to residents of Stanislaus County.

POLICY ISSUE:

Approval of this agenda item supports the Board of Supervisors' priorities of A healthy community, A safe community, and the Efficient delivery of public services.

STAFFING IMPACT:

There is no staffing impact associated with the approval of this agenda item.
