This represents an increase of \$60 from the amount of revenue typically received from the notification fee.

DISCUSSION:

Structural Pest Control Registrations

Prior to January 1, 2008, Structural Pest Control businesses were required to provide annual "notification" to the County Agricultural Commissioner before conducting business in the county. The Stanislaus County Agricultural Commissioner charged a \$10 notification fee to offset the cost of processing the notification requirement.

Legislation that passed in December of 2007 (AB 1717) nullified the notification requirement and instead, established in its place a county registration requirement effective January 1, 2008. The new mandate requires structural pest control businesses and their operators, field representatives and managers to register with the County Agricultural Commissioner prior to conducting business in the County. The registration covers the calendar year and expires on December 31. The required registration helps the Department to ensure that companies are trained, licensed and using pesticides safely that ultimately protects the public and the environment. While the legislation now requires "registration", the previous "notification requirement" was essentially a registration process.

The legislation also allowed county boards of supervisors to establish fees to cover the cost of registration. However, the registration fees are capped at \$25 for companies that perform structural fumigations and \$10 for companies that perform general pest control and/or non-fumigation termite control. Included in this report, is a chart that shows the new proposed structural pest control business registration fees at their capped amounts. In light of the current budget picture, this fee proposal is not an attempt to increase fees in order to offset budget reductions. The fee increase is simply a result of a law change and clean-up of an existing fee that will result in a slight increase of revenue amounting to approximately \$60.

Structural Pest Control businesses are divided into three categories depending on the type of pest control work they perform. They are referred to as Branch 1 (structural fumigation), Branch

2 (general pest control) and Branch 3 (non-fumigation termite control). The Branch 1 Structural Pest Control business notification fee of \$10 will change to a registration fee and will be increased to \$25. There are only four Branch 1 businesses operating in Stanislaus County that will be affected by this change. These companies have been notified by letter regarding the fee increase. The proposed registration fee of \$10 for Branch 2 and Branch 3 businesses is the same amount these businesses were paying in the past for County notification. The fee charged is for the business, managers, field representatives, and operators listed on the registration. As an example, a Branch 1 pest control business that registers with the County and lists all their operators and field representatives will be charged a single \$25 fee. Registrations can be amended during the year to add pest control operators, field representatives and managers for no additional fee.

Definitions: <u>Branch 1</u> structural pest control businesses are licensed to apply fumigants to structures for pest control (e.g. structural fumigations for termite control). <u>Branch 2</u> businesses are licensed to perform general pest control in and around structures. <u>Branch 3</u> businesses are licensed to perform non-fumigation termite control. Businesses with both Branch 1 and a Branch 2/3 licenses may be assessed both the Branch 1 and Branch 2/3 registration fees.

Authority to Charge Fees

AB 1717 (Chapter 338, Statutes of 2007), which amended California Food and Agricultural (F&A) Code Section 15204 and added F&A Code Section 15204.5, requires all Branch 1, 2, and 3 structural pest control companies to register annually with the County Agricultural Commissioner prior to conducting business in that county. Code Sections 15204 and 15204.5 also requires that the registration fee be set by the Board of Supervisors.

Comparison Counties

In researching proposed fee changes, fees charged by Stanislaus County were compared to valley counties performing the same activities. (See Page 5 for Comparison Table)

Device Registration

Device Registration revenue is the largest source of Weights and Measures revenue for the Department estimated at \$378,282 annually. Approximately 70% of the Weights and Measures annual workload is devoted to inspecting and testing commercial devices. There are more than 7,000 commercial weighing and measuring devices in use throughout Stanislaus County.

Device owner/users are required to register their devices with the Department and pay a registration fee to cover the cost of the inspection. On December 6, 2005, this Board approved the new device registration fee schedule as set forth in Business and Professions Code section 12240 and referenced in County Code chapter 4.36. County Code chapter 4.36 requires the annual registration fee to be the maximum set forth in Section 12240 of the Business and Professions Code, not to exceed the total cost of the County's inspection and testing program. The current annual registration fees collected of \$378,282 does not exceed the County's inspection and testing program cost which is currently \$473,028.

Business and Professions Code section 12240 allows a three-step increase over three years. The Department invoices businesses for their commercial device registration each January.

The new fee was first imposed in January 2006, followed by an increase in January 2007 and the final increase in January 2008. The January 2007 increase was included on the Department's fee schedule along with other fee amendments approved by this Board on May 8, 2007. The increase in Device Registration revenue from the January 2008 increase was \$82,231.

Since the Board has already approved the January 2008 fee increase on December 6, 2005, this agenda items is before the Board of Supervisors to make the necessary updates to the Department's fee schedule. The proposed fee schedule amendment reflects the January 2008 increases which represents the last increase under the current law.

POLICY ISSUE:

The Board of Supervisors should determine if approval of the new fees and the proposed fee amendments to County Code Chapter 9.45 and the fee schedule for the Agricultural Commissioner's Office supports the Board Priority to Promote the Efficient Delivery of Public Services and a Strong Agricultural Economy/Heritage.

STAFFING IMPACT:

The Department has sufficient staff and equipment to perform the services for Structural Pest Control registration. The recommended Board action will help maintain the current level of service.

ORDINANCE NO.	. C.S.	

AN ORDINANCE RELATING TO FEES CHARGED BY THE DEPARTMENT OF AGRICULTURE AND WEIGHTS AND MEASURES FOR REQUIRED AGRICULTURAL RELATED REGISTRATIONS

THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS, STATE OF CALIFORNIA, ORDAINS AS FOLLOWS:

Section 1. Chapter 9.45 of Title 9 is hereby amended in the Stanislaus County Code to read as follows:

"9.45 AGRICULTURAL REGISTRATIONS

9.45.010 Authority

California Food and Agricultural Code (FAC) Sections 11734, 11923, 12034, and California Labor Code Sections 1695 (a) (8) and 1695(b) authorizes the County Board of Supervisors to establish registration fees, to be paid to the Agricultural Commissioner, to recover the costs of processing required registrations for pest control businesses (including, but not limited to, maintenance gardeners and tree surgeons), pest control aircraft pilots, pest control advisers, and farm labor contractors, respectively.

FAC Sections 15204 and 15204.5 authorize the County Board of Supervisors to establish fees, to be paid to the Agricultural Commissioner, to recover the cost of processing required registrations of structural pest control businesses and their employees.

FAC Section 29044 requires the Secretary of Food and Agriculture to adopt registration fees for beekeepers, apiary operators, apiary owners, and other persons in possession of any apiary. The registration fee must

be paid when registering their bees with the Agricultural Commissioner.

The County Board of Supervisors may waive the registration fee for any beekeeper, apiary operators, apiary owners, or person, who is a hobbyist. A hobbyist is not in the business of beekeeping and possesses nine or fewer bee colonies.

9.45.020 Costs of Registration

Registration fees collected by the Agricultural Commissioner help offset the costs associated with the registration process. The process includes but is not limited to, processing paperwork, issuance of proofs of registration, and verifying educational requirements and/or eligibility to register.

9.45.030 Fee Methodology

The registration fees collected by the Agricultural Commissioner shall meet the requirements set forth in the FAC Sections 11734, 11923, 12034, 15204, 15204.5 and 29044, and Labor Code Section 1695 and be listed in the Department of Agriculture and Weights and Measures Fee Schedule as adopted by the Board of Supervisors. Any beekeeper, apiary operators, apiary owners, or person, who is a hobbyist is exempt from annual registration fees as set forth in FAC Section 29044."

Section 2. Fees to be collected by the Department of Agriculture and Weights and Measures are adopted and amended as set forth in the fee schedule attached hereto as Exhibit A, and added to the most current Department of Agriculture and Weights and Measures Fee Schedule, and incorporated by reference, a copy of which is on file with the Clerk of the Board of Supervisors and is available for public inspection and copying in that office in accordance with the California Public Records Act.

Section 3. This Ordinance shall take effect thirty (30) days from and after the date of its passage and before the expiration of fifteen (15) days after its passage it shall be published once with the names of the members voting for and against the same, in the Modesto Bee, a newspaper published in the County of Stanislaus, State of California.
