Approval for the Chairman to Sign a Letter of Support of the West Side Theatre Foundation's Application for a Full-Power Non-Commercial Educational FM Radio Channel to Serve the Gustine and Newman Communities Page 2

### **DISCUSSION:**

The West Side Theatre Foundation is actively pursuing the establishment of a community access radio station that would serve the communities of Gustine and Newman. Based on information received, the FCC opened a brief window in October, 2007, during which applications for full power (100 watts or more) NCE (Non-commercial Educational) channels on the FM (88.1-91.9) band. Project proponents have asked that the Stanislaus County Board of Supervisors provide a letter of support for the project.

The intent expressed by the West Side Theatre Foundation is to provide a community access radio station to serve the communities of Gustine and Newman. According to Foundation representatives, the station would provide a variety of programming options, including the following:

- Communicating social programs available locally
- Reaching out to underprivileged, isolated, and disabled audiences
- · A reading service for the blind
- Art, poetry, local affairs, and music shows focused on nontraditional formats not heard on "top 40" or NPR
- Educational programming of all sorts
- Public debate, social and voting issues, and non-corporate, independent news
- Involving the local schools to provide training to aspiring broadcasters
- Local Emergency Alert System (EAS) for weather and other alerts
- Local issues such as urban planning, preservation, land rights, local rights
- Forums for local community organizations (e.g. historical society, VFW, garden clubs, senior organizations, chamber of commerce)
- City Council meetings.

The County of Merced has already indicated its support for this initiative in a letter dated October 12, 2007.

## **POLICY ISSUES:**

The establishment of a community access radio station serving the communities of Gustine and Newman would add a new communications option to the region and enhance the community's ability to disseminate important information. This action supports the Board Priority of Effective Partnerships, a Strong Local Economy, the Efficient Delivery of Public Services and a Safe Community.
