#### **DISCUSSION:**

The Stanislaus Child Care and Development Planning Council was established by the Board of Supervisors pursuant to the State of California AB1542 & California Education Code 8499 on July 28, 1998 to provide a forum for the identification of local priorities for child care and the development of policies to meet the needs identified within those priorities.

California Education Code 8499 requires each local planning council by May 30<sup>th</sup> of each year, upon approval by the County Board of Supervisors and the County Superintendent of Schools, submit to the California Department of Education (CDE) any changes to the local priorities it identifies that reflect all child care needs in the county. The attached Stanislaus Child Care & Development Planning Council 2009-2010 Priorities Report reflects changes to the priorities in Stanislaus County.
