INVOLVING THE TRANSFER OF UP TO 10,000 ACRE FEET OF WATER
FROM THE SOUTH SUTTER WATER DISTRICT
TO THE 2009 DROUGHT WATER BANK
ADMINISTERED BY THE DEPARTMENT OF WATER RESOURCES
UNDER LICENSE 11118 (APPLICATION 14804)**

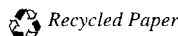
filed with the State Water Resources Control Board (State Water Board) a Petition for Temporary Change under Water Code section 1725, et seq. South Sutter Water District's (SSWD) petition requests the transfer of up to 10,000 acre-feet (af) of water to the Department of Water Resources' (DWR) 2009 Drought Water Bank (DWB) for use within the State Water Project (SWP) and Central Valley Project (CVP) service areas. Temporary changes approved pursuant to Water Code section 1725 may be effective for up to one year from the date of approval.

DESCRIPTION OF THE TRANSFER

SSWD proposes to transfer up to 10,000 af of water under License 11118 (Application 14804) to the DWR 2009 DWB. To facilitate the transfer, SSWD proposes to release an additional 10,000 af of water currently stored in Camp Far West Reservoir and Camp Far West Diversion Dam into the Bear River, tributary to the Feather River, thence the Sacramento River thence the San Francisco Bay/Sacramento-San Joaquin Delta. The water would be available for rediversion at the SWP's Banks Pumping Plant and Barker Slough Pumping Plant; Reclamation's Jones Pumping Plant and the Contra Costa Canal.

SSWD's petition states that its landowners receive their base water supply from groundwater pumping and receive supplemental water from Camp Far West Reservoir. The petition states that landowners will not change their cropping patterns due to the transfer. The petition states that in the absence of this transfer, the subject 10,000 af of water would either remain in storage within Camp Far West Reservoir or be released for use within SSWD.

PROPOSED TEMPORARY CHANGE

The proposed transfer would temporarily add the SWP Banks Pumping Plant and Barker Slough Pumping Plant and the CVP Jones Pumping Plant, and the Contra Costa Canal as points of rediversion under License 11118. The proposed points of rediversion are identified on maps filed with the State Water Board Division of Water Rights under Applications 5630 and 5626. Municipal and industrial, salinity control, fish and wildlife enhancement, water quality control, and stockwatering would be temporarily added as purposes of use under License 11118.

PETITIONER'S WATER RIGHTS

License 11118 (Application 14804) authorizes the diversion to storage of up to 58,370 af of water per annum from the Bear River between October 1 and June 30. License 11118 also authorizes the direct diversion from the Bear River of up to 330 cubic feet per second (cfs) between May 1 and September 1 of each year. The point of diversion to storage for License 11118 is located at the Camp Far West Dam. Additionally, the Camp Far West Diversion Dam (located about one mile downstream of the Camp Far West Dam) is an authorized point of diversion and rediversion to storage. The water is used for irrigation and domestic purposes within the authorized place of use, as well as incidental power generation. The authorized place of use under License 11118 is a net of 59,000 acres within a gross area of 65,796 acres within the SSWD, a net of 4,180 acres within the Camp Far West Irrigation District (including 102 acres outside its boundaries served under contract), and a power generation plant located on SSWD's conveyance canal.

In order to protect fish resources downstream of the Camp Far West Diversion Dam, SSWD is required to bypass 25 cfs between April 1 and June 30 of each year and 10 cfs between July 1 and March 31 of the succeeding year. Additionally, SSWD (with other parties within the Bear River watershed) has entered into an agreement (referred to in State Water Board Decision 1641 as the Bear River Agreement) with DWR to meet the Bear River watershed's responsibilities for Bay-Delta flow objectives. This agreement requires SSWD to make up to 4,400 af of water available to DWR during dry and critical water years. SSWD's petition states that the water intended for transfer is in addition to the water released to DWR pursuant to the Bear River Agreement. Additional information regarding the Bear River Agreement is on file with the State Water Board under Application 14804.

COMPLIANCE WITH CALIFORNIA ENVIRONMENTAL QUALITY ACT

Temporary changes involving the transfer of water that was previously stored are exempt from the requirements of the California Environmental Quality Act (CEQA).

However, the State Water Board must consider potential impacts to other legal users of the water and to fish, wildlife, or other instream beneficial uses.

STATE WATER RESOURCES CONTROL BOARD'S STATUTORY PROVISIONS

Pursuant to Water Code sections 1725, et seq., the State Water Board is authorized to issue temporary change orders, allowing the transfer or exchange of water or water rights after completing an evaluation and finding that the proposed temporary changes:

1. Involve only water that would otherwise have been consumptively used, stored, or conserved pursuant to Water Code section 1011, by Permittee;
2. Would not injure any legal user of the water;
3. Would not unreasonably affect fish, wildlife, or other instream beneficial uses; and
4. Any increase in groundwater pumping associated with this transfer (i.e., groundwater substitution) is performed in compliance with Water Code sections 1745.10 and 1745.11.

If the State Water Board cannot satisfy, in a timely manner, the provisions of Water Code section 1725, et. seq., then the State Water Board may deny the petition or schedule and notice a hearing regarding the proposed transfer or exchange of water.

OPPORTUNITY FOR COMMENT

Pursuant to the requirements outlined above, the State Water Board is seeking information to assist in the evaluation of the proposed temporary change of water rights. Any person may file comments concerning the petition for temporary change. The comments must address the required findings set forth above. The petitioner has the burden of establishing that the proposed temporary change will not injure any legal user of water, or unreasonably affect fish, wildlife, or instream beneficial uses. If the State Water Board determines that the petitioner has established a prima facie case, the burden of proof then shifts to the party that has filed comments (Water Code section 1727). While such a determination has not been made in this case, commenters should provide sufficient information to support claims of injury or effects on fish, wildlife, or other instream uses.

Due to the relative brevity of the temporary transfer process, the Division of Water Rights (if necessary) may request that the petitioner submit additional information during the comment period. Any such requests and any additional information

each filed with the State Water Resources Control Board (State Water Board) a Petition for Temporary Change under Water Code section 1725, et seq. The parties represented by MBK Engineers are Reclamation District No. 1004 (RD 1004), Garden Highway Mutual Water Company (GHMWC), DL Goose Farms, LLC and Teichert Aggregates (GF), Greg Amaral Ltd. Pension Plan and Trust and Tule Basin Farms, LLC (Guisti Ranch), Pelger Mutual Water Company (PMWC), and five member landowners of the Pleasant Grove-Verona Mutual Water Company (PGVMWC). Petitions were also submitted by Sacramento River Ranch, LLC (SRR) and Reclamation District No. 108 (RD 108). The petitions request the transfer of a combined total of up to 39,018 acre-feet (af) of water to the Department of Water Resources' (DWR) 2009 Drought Water Bank (DWB) for use within the Central Valley Project (CVP) and the State Water Project (SWP) service areas. Temporary changes approved pursuant to Water Code section 1725 may be effective for up to one year.

BACKGROUND

In response to Governor Schwarzenegger's June 4, 2008 Executive Order, the DWB was initiated in the summer of 2008 to help alleviate the drought conditions should they continue into 2009. DWR established the DWB to purchase water from willing sellers upstream of the Sacramento-San Joaquin Delta. This water will be transferred using SWP or CVP facilities to water suppliers that are at risk of experiencing water shortages in 2009 due to drought conditions and that require supplemental water supplies to meet anticipated demands. Due to similarities in the requested changes, the State Water Board is issuing one public notice for these twelve petitions.

DESCRIPTION OF THE TRANSFER

The petitioners propose to transfer water to the DWB in order to provide an additional water supply for participating agencies. The total amount of water intended for transfer pursuant to these twelve petitions is 39,018 af. The petitioners hold twelve water right licenses cumulatively authorizing the direct diversion of approximately 424 cubic feet per second (cfs) of water from the Sacramento River or its tributaries (between the cities of Colusa and Sacramento) for irrigation use. Table 1, on page 3, identifies the specific water right licenses under which each of the twelve petitions were filed, the amount of water each Petitioner proposes to transfer, the corresponding rate of diversion, and the transfer type.

In order to make water available for transfer, the petitioners have proposed to reduce their consumptive use (CU) by a like amount. The majority of this reduction will be achieved by increasing groundwater pumping to make surface water available for transfer (groundwater substitution). The remaining CU reduction will be achieved by voluntary fallowing of lands which, absent the transfer, would have been planted (crop idling) and varying the types of crops planted to reduce water demand (crop shifting). The petitioners have stated that groundwater substitution and crop shifting/idling for the proposed transfers will be in accordance with the guidelines contained in DWR's Water Transfer Papers, at: <http://www.watertransfers.water.ca.gov/geninfo/geninfo.cfm>.

Since water is being transferred for use by the DWB, DWR and the United States Bureau of Reclamation (USBR) will be reviewing each transfer proposal.

PROPOSED CHANGES

Each petition requests the following temporary changes, shown in Table 2, below, to their respective water right license:

1. Add the SWP and CVP service areas to the place of use;
2. Add the Jones Pumping Plant, the Banks Pumping Plant, the Barker Slough and the Contra Costa Canal as points of diversion; and
3. Add domestic, power, municipal, industrial, salinity control, fish and wildlife enhancement, water quality control, and stockwatering (as needed) to the authorized purposes of use.

If the State Water Board cannot satisfy, in a timely manner, the provisions of Water Code section 1725, et. seq., then the State Water Board may deny the petition or schedule and notice a hearing regarding the proposed transfer or exchange of water.
