I, Raymond S. Castro, with to resign my position on the South Modesto Municipal Advisory Council. My reasons are many, but I will only mention a few. First, Law Enforcement in my neighborhood is zero. Since Adam Christian took office in the Sheriffs Dept. There are more drug dealers and gang activity, prostitution and also so called "birthday parties" which are nothing but more selling of drugs, drug and alcohol use, loud music and party goers harassing us. Enclosed is Adam Christian's order to Sheriffs dispatch "Not to respond to my noise complaint from my address. I have called the Watch Commander and left messages. I have asked our Supervisor, Jim Dimartini to call the Watch Commander and Sheriffs Dept, to which no response was made. Is it my fault we have these people like loud music and do drugs? Is it my fault the District Attorney would not prosecute for noise complaint? Is it my fault that the D.A. did not let us know the noise ordinance we had was no good.

In October 2009, it will be two (2) years that we began a new one. It is obviously too long, since we are supposed to have college educated people working for us.

Code Enforcement, is case where a shed was burned (electrical problems) was to be demolished in 2007 the shed is still there and a roof has been added to it. Code enforcement should not be complaint driven but followed through.

Pollution Control told me they would not come out for safety reasons, so when we smell smoke at night, there's nothing we can do. Because we complained of the problems in our neighborhood we are told by the very people that are paid to take care of these problems that we complained too much. Finally, my family and I have been cursed and threatened. According to these people we are the only ones who complained to officials about them. My house has been egged. Food like burritos, tacos, oranges, lemons, grapes, marbles and garbage has been thrown at my house. Garbage left in front of my house.

These people don't want a better neighborhood, only to keep it the same or worse. What finally convinced me to resign was the Cinco de Mayo celebration, in which these people where driving wrecklessly through neighborhood, drunk driving, guns fired off, and as you well know a person was killed 2 ½ blocks from my residence.

When the Sheriffs Dept does not respond to these so called "birthday parties" all it does is give these people the green light to do as they please. Also, when the County issues permits for celebrations like the Cinco de Mayo.

I have hoped that I would help Area I, II and now III a better place in which to live and help our children become productive members of society. But I learned people create all these problems and even though we may have lights, sidewalks, sewers and nice streets. The real problems still remain, because we still have the same kind of people living here and coming to our neighborhood.

Please accept my resignation.

The noise problem greatly reduces our quality of life. How can we and our children sleep, study, read, pray, watch television or listen to our own music. For me when I was working 12 hours a day from 3:00am to 3:00pm, sometimes 6-7 days a week, I had to wait until after 10:00pm to complained about loud music. By the time the Sheriffs Dept showed up, if they did, I had to get up and go to work with only a couple hours of sleep.

Sometimes the loud music went on day and night. I believe it damages childrens hearing and causes some people to become extremely angry, since we cannot do anything about it. But worse of all, is the fact that the Sheriffs Dept and District Attorney would do nothing to help us. They would not dot the job that they are getting paid to do.

It is my opinion that some County Depts have taken upon themselves to choose and pick what they want to do and not what they get paid to do. And that God fearing American citizens and tax-payers keep getting the wrong end of the stick. The County keeps paying for some peoples' bad behavior, which is the same as promoting bad behavior, while some senior citizens have to eat cat food, Letter to the Editor – Modesto Bee.
