# FISCAL IMPACT (CONTINUED):

Subscribers to residential basic service; that is, 1-90 gallon cart, curbside recycling, and bulky item collection, may see changes in their monthly service charges ranging from a 2.45% decrease to a 8.67% decrease. Proposed commercial bin rate adjustments range from a 3.96% decrease to a 8.28% increase. Proposed franchise drop-box haul charge adjustments range from a 34.9% increase to a 93.2% increase.

#### **DISCUSSION:**

Through much of 2008, Department of Environmental Resources staff have worked with the consulting firm of Hilton, Farnkopf & Hobson, LLC, and the four franchise refuse collection companies to develop new "base" solid waste collection rates (Base Rates). Costs related to curbside recycling and the bulky item program are included in the residential Base Rates.

On November 4, 2008, the Board of Supervisors adopted new Base Rates (please see Attachment "A") from which the maximum franchise rates for solid waste collection services in the unincorporated areas of Stanislaus County would be set beginning July 1, 2009.

At the same meeting the Board approved a new methodology for the annual adjustment of these Base Rates. For four consecutive years, these Base Rates may be increased or decreased only by the change in a series of consumer and other price indexes. Every fifth year, a detailed cost of service study will be repeated to determine new Base Rates, followed by another four years of index-based adjustments, and so on.

The following indices and their respective changes (i.e., the difference between the April 2007 – March 2008 average, and the April 2008 – March 2009 average) have been applied to the indicated components of the individual companies' residential and commercial Base Rates. Only the labor, fuel, collections, and interest adjustments have been applied to the Drop Box Base Rates because the County sets only the haul charges for these services. Disposal, transfer, and franchise fees are billed to the customer directly by the companies as part of the service charge.

\*For this year only, the County's consultant has advised that a "manual" adjustment in the fuel component is more appropriate than applying the prescribed index noted above. The fuel expense adjustments included in the Base Rates were based on an anticipated average of \$4.60 per gallon during fiscal year 2008-2009. The actual average price of California No. 2 Diesel Retail Sales by All Sellers was \$3.57 per gallon for the period of April 2008 through March 2009. As a result, the Fuel Component has been changed from 8.88% to -22.39%.

\*\*When the projected total compensation increases or decreases based on the net of the adjustments listed above, the expense included in the proposed rates for Franchise Fees must also be increased or decreased. This Component is included to make the franchise haulers "whole" at covering the exact amount of the County's 8% franchise fee.

Noted above and included in the proposed residential and commercial rates is the increase in the disposal fee at the Fink Road Landfill, from \$30 per ton to \$33 per ton, approved by the Board at their April 21, 2009, meeting and effective July 1, 2009.

It should also be noted that the current Rate Adjustment Process "caps" rate adjustments, up or down, at 5% per annum. Several of the proposed rate adjustments are greater than 5% when measured against the rates in effect today. This limit was, however, intended to apply to the annual change once the new Base Rates are in effect. This means that the "cap" will become effective for the review period effective July 1, 2010, through July 1, 2012, after which a detailed rate review would again be required.

The proposed rates (please see Attachment "A") are presented in a format that identifies the following: the change between the rates approved by the Board for 2008-2009 and the approved Base Rates; the change between the Base Rates and the rates currently being proposed with the appropriate indices applied; and the net change

between the rates customers are have paid over the past year and the rates proposed for 2009-2010.

### Request for Proposals (RFP) for Franchise Area # 3

As the Board is aware, an RFP for Franchise Area #3 was issued on February 10, 2009, and bids were due on April 29, 2009. Two proposals were received and the review of them is currently underway. The RFP requested proposers to bid firm compensation requirements for the period November 5, 2009, through June 30, 2012. Given this, if the Board approves staff's recommendations, collection rates for residents and businesses in Franchise Area # 3 will change on July 1, 2009, as part of the regular adjustment cycles, and as a result of the RFP award and anticipated Board approval, may change again on November 5, 2009.

#### POLICY ISSUE:

The Board of Supervisors is required to set a public hearing prior to adjusting the maximum rates for solid waste collection services. After the public hearing, the rates could be changed. The Board of Supervisors should determine if adjusting the maximum rates for solid waste collection services is consistent with its priorities of a safe community, a healthy community, and a well-planned infrastructure system.
