SUBJECT:

Approval to Accept Beverage Container Recycling Funds from the California Department of Conservation for Fiscal Year 2009-2010

STAFF RECOMMENDATIONS:

1. Authorize the Director of the Department of Environmental Resources, or her designee, to accept Beverage Container Recycling Funds from the California Department of Conservation for Fiscal Year 2009-2010 to promote beverage container recycling and litter clean-up on behalf of the unincorporated areas of Stanislaus County.
2. Direct the Auditor-Controller to increase appropriations and estimated revenue in the amount of \$29,896 for Fiscal Year 2009-2010 as detailed in the Budget Journal Form.

FISCAL IMPACT:

Approval of this item will provide \$29,896 in Fiscal Year 2009-2010 to the Department of Environmental Resources' Beverage Container Recycling Account for expenses to promote beverage container recycling and litter clean-up in the unincorporated areas of Stanislaus County.

**DISCUSSION:**

In the 1980's, Assembly Bill 2020 (AB 2020), more commonly known as the "Bottle Bill," was enacted. It was this legislation that created the point-of-purchase surcharge on most bottled beverages, such as soda pop, wine coolers, beer, etc.

Changes to AB 2020 were made in 1999 prior to the "sunset" of the legislation. The most significant change for local government was the return of some of the surcharge monies to the local level for the enhancement of beverage container recycling efforts. Specifically, Section 14581 (a) (4) (A) of the Beverage Container Recycling and Litter Reduction Act was revised to require that \$10.5 million be returned annually to cities and counties on a per capita basis. Jurisdictions can apply for funds either individually or jointly.

The Board of Supervisors approved applying for these funds on May 19, 2009. The Department was notified on June 22, 2009 that Stanislaus County's funding for the period of 2009-2010 will be \$29,896. Funds will be used to supplement existing recycling efforts as follows:

1. The Recycling Poster Contest in elementary and middle schools throughout the unincorporated areas of the County;
2. Production of a recycling calendar using winning Poster Contest entries;
3. Updating and redesign of recycling pages on the County website;
4. Equipment and supplies such as recycling containers and signs for public areas;
5. Advertising, which is tailored to support local programs;
6. Promotional items to support these programs and close the loop through the purchase of end-use items such as park benches/tables containing recycled content; and
7. Staffing costs associated with the administration of recycling activities.

**POLICY ISSUE:**

The Board of Supervisors should determine if accepting Beverage Container Recycling funds from the California Department of Conservation is consistent with the Board's priorities of effective partnerships and the efficient delivery of public services. Recycling programs such as these assist Stanislaus County jurisdictions in meeting the 50% waste diversion mandate as specified by statute.

**SUBJECT:** City/County Payment Program Enactment of AB 7 (8X)

With the recent passage of AB7 (8X), the Department of Resources Recycling and Recovery (Department) is required to pay in full, subject to the availability of funds, any payments that have been proportionally reduced during the period of January 1, 2010, through June 30, 2010.

City/County payments will be paid at 55% of the total \$10.5 million appropriated for Fiscal Year (FY) 2009/2010, or \$5.775 million. The formula for allocating the funding will remain the same. Each city is eligible to receive a minimum of \$5,000 and each county is eligible to receive a minimum of \$10,000 or an amount calculated by the Department based on per capita, whichever is greater. The Department is anticipating making these payments prior to the end of FY 2009/2010.

Based on current expectations of revenues, including accelerated distributor payments, Fund condition projections, and General Fund loan repayment schedules, it is anticipated that funding will be restored to \$10.5 million for FY 2010/2011. Please note this is subject to the availability of funds.
