FISCAL IMPACT: U.S. Housing and Urban Development (HUD) allocation for the Stanislaus County Consortium to implement the new Recovery Act Funds (CDGB-R) is in the amount of \$669,134. The Department of Planning and Community Development will administer the program for the County. Administrative costs are estimated to be approximately 10% (or \$66,913) of the total allocation as directed per HUD guidelines. Approval to Authorize the Auditor Controller to Establish Budget for Community Development Block Grant – Recovery Act Funds (CDBG-R) Page 2

# DISCUSSION:

On June 2, 2009, the Board of Supervisors approved the amendment to the Community Development Block Grant (CDBG) Fiscal Years 2007-2012 Consolidated Plan and Fiscal Year 2008-2009 Annual Action Plan to incorporate the Housing and Urban Development (HUD) Community Development Block Grant – Recovery Act funding. The Stanislaus County Consortium received an allocation of \$669,134.

The funding is provided through HUD under the American Recovery and Reinvestment Act of 2009 as a special CDBG allocation. Funding available under the Recovery Act has clear purposes — to stimulate the economy through measures that modernize the Nation's infrastructure, improve energy efficiency, and expand educational opportunities. The funds will be monitored under the established Stanislaus County Rehabilitation Program format, which includes quarterly monitoring visits to ensure effective and timely use of funds and utilization in an eligible manner. All allocated funds will be expended within a 24 month period.

During the Board's action to incorporate the CDBG-R funding into the County's Fiscal Years 2007-2012 CDBG Consolidated Plan and Fiscal Year 2008-2009 Annual Action Plan, authorization to establish the budget for the County's allocation was omitted in error. At this time, the Planning and Community Development Department would like to request authorization for the Auditor-Controller's Offices to establish estimated revenues and appropriations for the new grant funding.
