FISCAL IMPACT: (Continued)

With U.S. Department of Housing and Urban Development (HUD) grants and prior years of carryover reserves from annual allocations to the Stanislaus County Redevelopment Agency, this is a budgeted activity and there are funds available to cover the costs associated to deliver this phase of the project.

It is proposed to form a County Service Area (CSA) for Phase 1A. County Service Areas (CSAs) are generally formed when new improvements are installed providing a special benefit to those receiving the improvements. These special benefit services may include, but not be limited to monthly or bi-monthly street sweeping, park and streetscape maintenance and storm water system maintenance to ensure maximum service life of the system. CSA formation requires approval of the Local Area Formation Commission (LAFCO) and a majority vote of property owners within the improvement area. If the formation fails, the Department of Public Works will provide the minimum maintenance required to keep the storm drain system functioning however, it is anticipated that the system would fail before the maximum service life is realized. The cost of this minimum maintenance is estimated to be approximately \$5,000/year and will be absorbed into the Public Works Road Operations budget.

The formation proceedings for Phase 1A will be conducted concurrently with the construction schedule. The Department of Public Works anticipates returning to the Board to seek approval to initiate proceedings for the formation of this County Service Area in the near future. Additional improvements, excluding Phase 1A, within the preliminary master plan for the Empire Infrastructure Improvement Project, will be conditioned upon the successful formation of a County Service Area to cover ongoing maintenance costs.

DISCUSSION:

In March of 2006, the Board of Supervisors authorized the County to enter into a contract with Stantec Consulting Inc. to provide design, surveying and general engineering services to develop plans and specifications for the Empire Infrastructure Improvement Project. This design project is the first step toward the ultimate realization of storm drain infrastructure in Empire and is funded by the Community Development Block Grant (CDBG) Program and the Stanislaus County Redevelopment Agency.

A preliminary master plan has been developed to provide positive storm drainage for the entirety of the town of Empire. Due to funding constraints, the Planning and Community Development Department, in conjunction with the Department of Public Works has developed an initial plan for construction of only a small portion of the overall Master Plan. Phase 1A (Base Bid) consists of installing curb, gutters, handicap returns, new street section, a positive storm drain collection system and a self-contained underground french drain. The Phase 1A plan encompasses the area generally bounded on the south by Highway 132; on the west by E Street; on the east by I Street; and, on the north by 2nd Street and Center Avenue. This area was considered due to the geographical location and its proximity to the school, the developed park, the open

play area and the new pool facilities (Regional Water Safety Training Center). The Census 2000 data of the Median Household Income was also used. If the Base Bid is below the engineer's estimate, staff will consider recommending also awarding the bid additive which will include F Street, G Street and Sunshine Court, south of Highway 132. Attachment 1 provides a map illustrating Phase 1A project area, including the bid additive.

All of the right-of-way for this project has been acquired and utilities will be relocated by the utility companies in coordination with the contractor. Staff has completed the review of the plans and specifications and recommends that the Board of Supervisors adopt the plans and specifications, authorize staff to set the bid opening date and time, publish notice inviting bids as required by law, and mail a notice inviting bids to trade journals as required by law.


