Approval for JAFCO Canine Management to Have Exclusive Use of Woodward Reservoir Area BB for their 28th Annual Canine Water Working Seminar for Law Enforcement Officers from September 16, 2009 to September 20, 2009

DISCUSSION:

A request has been received from JAFCO Canine Management to have exclusive use of Woodward Reservoir Area BB (Attachment A) from Wednesday, September 16, 2009 beginning at 12:00 p.m. (Noon) to Sunday, September 20, 2009, ending at 4:00 p.m. for their 28th Annual Canine Water Working Seminar for Law Enforcement Officers.

Woodward Reservoir is located at 14528 26-Mile Road a few miles north of Oakdale off Highway 120. This regional park offers 3,767 acres of land and 2,900 acres of reservoir for recreation and camping. The facility can accommodate tent, trailer, and recreational vehicle camping including full hook-up, developed and undeveloped campsites. Daily recreational opportunities include swimming, fishing, boating, picnicking, water and jet skiing, waterfowl hunting, and radio control airplane flying. Woodward Reservoir is also home to the Annual Fireworks Celebration. Area BB (Attachment B) is a developed area of the facility located along the waters edge. It is a designated camping area having at least three of the following: a designated number sign, vehicle parking space, a picnic table, a fire grill, or a storage cabinet.

JAFCO Canine Management has been using Woodward Reservoir for the last 28 years for their Canine Water Working Seminar. Due to the economic hardship faced by many law enforcement agencies throughout the area and the reductions in training budgets, law enforcement officers are faced with a decision to pay for training out of their own pocket or not to attend at all.

Attendees at this event are police K9 officers and their K9s. Their purpose is to have the opportunity for the handlers to work with their dogs, condition their dogs, and to strengthen their water environment skills. While on site, all attendees are available to assist in any law enforcement issue should the need arise.

The Department of Parks and Recreation does not have any objections to this request for exclusive use and as such necessitates JAFCO Canine Management to adhere to the following requirements:

- JAFCO Canine Management and its staff shall work with other necessary groups, organizations, or other governmental personnel as determined by applicable codes, laws, and regulation to ensure a safe event.
- By Tuesday, September 15, 2009, no later than 5:00 p.m. require JAFCO Canine Management, to provide the Department of Parks and Recreation a Certificate of Insurance with a minimum general liability of \$1 million and endorsement naming Stanislaus County as an additional insured.
- A Hold Harmless Agreement (Organization) is required. The original agreement must be completed and returned by Tuesday, September 15, 2009, no later than 5:00 p.m.
- Camping fees for this exclusive use are reduced from \$15 to \$7 per vehicle per night.

- The area is to be left in a clean condition with all litter/debris in trash receptacles.

POLICY ISSUE (S):


