FISCAL IMPACT: This action will allow Stanislaus County to recover costs associated with the demolition of the structure located at 508 Imperial Avenue, Modesto, CA. Final demolition costs, including the contractor fees, staff time and incidental expense, a total cost of \$10,060.60.

Approval to Adopt the Recommendations of the Nuisance Abatement Hearing Board Regarding the Cost Accounting to Abate the Nuisance DAD2008-00005 at 508 Imperial Avenue, Modesto, CA 95354 Page 2

DISCUSSION:

At the request of fire dispatch, on November 1, 2008, the Planning & Community Development Department, Building Permits Division conducted a field investigation that revealed a fire damaged structure (dwelling) refuse and debris on the property located at 508 Imperial Ave, Modesto CA. 95354.

A certified letter was sent to the owner with the recommendation to demolish the structure and clean-up refuse and debris. The letter was returned. On December 15, 2008, Department staff received notification from Donna Sutton, Supervising Public Administrator for Stanislaus County, that the Public Administrator's office had been given authority to administer the estate through an Ex Parte Order to Summarily Dispose of the Estate. A "Notice and Order" was mailed and posted, and a Certificate of Existence of Dangerous Building was recorded by the Stanislaus County Clerk Recorder's Office. Approval was given for demolition and clean-up by the Nuisance Abatement Board on May 28, 2009, with the Board of Supervisor's approval on June 9, 2009. The demolition of the dwelling and clean-up of the property was completed on August 3, 2009, at a total cost of \$10,060.60.

On September 24, 2009, the Nuisance Abatement Hearing Board supported staff's recommendation that the billing was reasonable and forwarded the matter to the Board of Supervisors. By adopting the decision of the Nuisance Abatement Hearing Board, the Board of Supervisors affirms the reasonableness of the billing. A detailed accounting of the billing is attached as Decision of Costs (Attachment 1) and Cost Accounting Staff Report (Attachment 2).

This request would authorize the Treasure/Tax Collector to recover these costs by special assessment and a lien upon the property; cause the same to be recorded on the assessment roll; and thereafter, said assessment shall constitute a special assessment against and a lien upon the property. The proceeds received in satisfying the lien shall be paid to Stanislaus County Treasurer, who shall transfer the funds to the Dangerous Building Abatement Fund No. 1746 (Org. #0043290).

POLICY ISSUES:

The Board should decide if it should accept, modify, or reject the written decision as presented in the Decision of Costs DAD2008-00005 (Attachment 1). Acceptance of staff's recommendation would be consistent with the Board's priorities of providing a safe community and healthy community by removing dangerous structures and efficient government operations by recovering associated costs.

STAFF REPORT **COST ACCOUNTING**

On June 9, 2009 the Stanislaus County Board of Supervisors, through Board Action No. 2009-385, adopted the finding of the Nuisance Abatement Hearing Board for the existence of a nuisance at 508 Imperial Ave, Modesto, CA. APN 056-047-047. This directed staff to conduct a forced Demolition of the Dwelling and Clean-up of the property listed above, if the property owner failed to comply within the time period stated in the Notice and Order which was March 27, 2009. On August 3, 2009 the Department Planning and Community Development, Building Permits Division conducted the forced Demolition and clean-up at 508 Imperial Ave, Modesto, CA. Prior to the Demolition and clean-up, the Building Permits Division staff used the approved methods by the Board of Supervisors and obtained three bids for the action from Contractor's permitted by Stanislaus County. The Cost Accounting for the Demolition and clean-up is attachment AA. On August 27, 2009 the billing statement, requesting payment was mailed to Donna Sutton, Supervising Public Administrator, authorized to summarily Dispose of estate for Vetra Jones (Deceased) for Demolition and Clean-up. They were allowed fifteen (15) days to appeal these costs and demand a public hearing. Since an appeal was not demanded within the fifteen (15) days, the Nuisance Abatement Hearing Board is requested to approve the cost accounting for the Demolition and Clean-up as reasonable. The Nuisance Abatement Hearing Board heard the above-referenced matter on **May 28, 2009**. Upon consideration of oral and documentary evidence presented at the hearing, the Nuisance Abatement Board finds and determines as follows:

- 1. The property located at 508 Imperial Ave., Modesto, CA, in the unincorporated area of Stanislaus County, California, also identified as Assessor's Parcel Number 056-047-047, is zoned R-1, Single Family Residential District.
- 2. County Staff confirmed the existence of and presented evidence of violations of Stanislaus County Codes occurring on the property, as noted in "Attachment A."
- 3. All owners of record, tenants and others, holding interest of record in the Property as identified and listed in the title report contained in the staff report regarding this matter. The Assessors Inquiry lists as the owner(s) of record for the property as Vetra L. Jones (deceased) but the property has been turned over to the Public Administrator's Office C/O Donna Sutton.
- 4. All interested parties were served a Notice and Order to Abate pursuant to Stanislaus County Code Section 2.92.030, describing the conditions or use of the property that constitutes the violations and ordering abatement of those conditions.
- 5. County staff has attempted to obtain voluntary compliance by the interested parties, and the interested parties have had significant and reasonable time to correct all violations but have refused and/or failed to meet the deadlines prescribed by Notice.
- 6. The owners have the legal responsibility for maintenance of the property in conformance with the applicable law, ordinance and rules, including abatement of all violations and compliance with all orders of the County.
- 7. The interested parties were served proper Notice of Hearing to Abate Nuisance pursuant to Stanislaus County Code Section 2.92.070.
- 8. Based on the evidence and testimony presented at the hearing, which is incorporated herein by reference, there is substantial evidence that violations of the Stanislaus County Code, as set forth in the staff report for the matter, still exists on the property.

9. Pursuant to Stanislaus County Code Section 2.92.010, the continuing violations that exist on the property constitute a public nuisance.

NOW THEREFORE, the Nuisance Abatement Hearing Board recommends that the Stanislaus County Board of Supervisors:

- Order the owner and interested parties to abate the nuisance on the property within two weeks from the date of the Board decision by correcting the condition or use of the property as set forth in the staff report on this matter.
- Authorize the County to abate the nuisance and to charge the costs of the abatement to the County if the Owners or other interested parties do not abate the nuisance within the specified time period.
- 3. Authorize County staff, pursuant to Stanislaus County Code Section 2.92.070, to dispose of any material, equipment, vehicles or other personal property removed from the property to abate a nuisance in any manner authorized by law, and to charge the costs of disposal to the owners and/or interested parties as part of the cost of abatement.
- 4. Authorize County staff to charge the owners and/or interested parties for County staff time incurred to investigate through the Abatement Hearing.
- 5. Order a Notice of Abatement Lien be recorded against the property if the owners and/or interested parties fail to pay the costs demanded by the County.
